Two-Day CPI National Executive Meeting CALL TO STRENGTHEN INDIA BLOC

The two-day meeting of the national executive of the Communist Party of India (CPI) held in the central party headquarters, Ajoy Bhavan in New Delhi on September 19 and 20 has decided to try its level best to strengthen the INDIA bloc by mobilizing people and by bringing various organizations of workers, peasants, youth, women, students and other social movements around the INDIA bloc.

CommunistParty of India general secretary D Raja issued the following communiqué at the press conference on September 21, 2023 after the conclusion of the two-day national executive meeting:

The National Executive of the Communist Party of India had its meeting on 19 and 20 September, 2023 at New Delhi. The meeting was chaired by Vanaja, member of the national executive and member of the state secretariat of the party in Andhra Pradesh.

Party general secretary D Raja reported on the political developments including the formation of Indian National Development Inclusive Alliance (INDIA). He also explained what should be party's approach and role in forging alliance in states to fight elections for the state assemblies and elections for the Lok Sabha.

After deliberations, the national executive expressed its view on the following issues:

On Women's Reservation Bill

Communist Party of India stands for women empowerment and for gender equality. It was CPI leaders and members of Parliament like Renu Chakravarti and Geeta Mukherjee, who championed the cause of women's reservation in assembly and Parliament. It was in 1963 that Renu Chakravarty raised the issue in Parliament. In fact, Geeta Mukherjee as head of the Parliamentary Select Committee recommended 33 per cent reservation for women.

In this background, CPI welcomes the reservation bill but points out that it is 2024 election and formation of INDIA alliance, which has rattled the BJP government and forced the government to adopt the bill. Bill Passed, But...

After a very long wait, the Women's Reservation Bill has been passed by the Parliament. Everyone who knows about the history of the struggle for the enactment of the Women's Reservation Bill would think about Comrade Geeta Mukherjee at this moment of victory. She was the unforgettable communist leader and a consistent fighter for women's rights who took the passing of the women's bill as a life mission. She was a true communist who believed that the tasks of the Indian revolution could not be fulfilled without the liberation of the women of the country. Thirtythree per cent participation of women in the Parliament and state legislatures is only the first step in that direction. Even for that first step to be accomplished, the democratic forces of the country had to wage consistent battles for decades. Passing the bill would be an impetus for the future struggles of women's organisations and other democratic forces.

The BJP government is trying to capture the scene as the champion of women empowerment in the country. All their propaganda measures are tuned accordingly and they propagate that Narendra Modi is the crusader of women's rights. Contrary to the hype being built, the fact is that Narendra Modi and his party are not at all sincere in the enactment of the Women's Reservation Bill. They are ideologically and politically not in favour of women empowerment. Theirs is a male chauvinistic organisation controlled by the RSS in which women are denied even primary membership. Their ideology is guided by Manu Smriti, that preaches 'Na sthree swathanthryam arhati' (women do not deserve freedom)". All of a sudden, their government became advocates of nari shakthi and wanted to crown it with this bill. Electoral compulsions were overpowering ideological convictions inside the BJP. Otherwise, how

can they justify the long lapse of nine years, from 2014 to 2023, for initiating this bill?

The content of the Women's Reservation Bill was shaped by the United Front government in 1996, in which the Communist Party of India also held important positions. It could not be passed then because of differences regarding reservations for the OBCs. A Joint Parliamentary Committee led by Geeta Mukherjee was formed on this behalf. Though it presented its report in record time, the move could not go forward as the bill had lapsed with the dissolution of the Lok Sabha. During the period of the Vajpayee government, there was no considerable progress in the matter. The UPA-I, in which the left parties played a significant role, took the matter seriously and the Women's Reservation Bill found an important place in the Common Minimum Programme. During this government led by Dr



Manmohan Singh, the bill was introduced on May 6, 2008. After Standing Committee scrutiny, the Rajya Sabha passed the bill on March 9, 2010. From that point, due to political uncertainties, there were no serious developments on the matter.

The Communist Party of India and the left forces have always been strongly committed to the Women's Reservation Bill and continued its struggle along with the progressive women's movement in the country. The National Federation of Indian Women (NFIW) took this struggle to the Supreme Court in 2021 in the form of a Public Interest Litigation. In the course of hearings in this important matter, the apex court also took a firm stand and cautioned the government of serious repercussions if the enactment of the bill is further delayed. Along with the 2024 elections, various factors compelled the BJP government to come forward with the legislation. Though this

is a historical turning point in the direction of women's empowerment, the BJP is not at all sincere in its implementation. In the name of the forthcoming census and delimitation of constituencies, the government attempts to delay its implementation for any further period of time. That should be resisted. The democratic forces of the country urged the government to implement the Women's Reservation Bill without any further delay after the dissolution of the current Lok Sabhaitself.

The experience with the reservation for women from one-third (33 per cent) to onehalf (50 per cent) of the total seats in panchayats and local urban bodies has shown us how giving reservation to women in governance could bring in a positive change in our political landscape. This should be the fuel for furthering the objectives of genderinclusive politics. The scope of the present Act should be extended to the Rajya Sabha, the state legislative councils as well as the assemblies of all Union Territories. Reservations for OBCs and minorities in the law-making bodies are vital for a meaningful representative democracy. The Geeta Mukherjee committee report has also mentioned this aspect. The stage managers of the BJP, who now boast about the Act, have never applied their minds to such important questions till this moment. Their only concern is the capture of power in the name of nari shakthi. Sharing power with women and respect for social justice do not feature on their political and ideological agenda. They should be exposed before the people. From this first point of victory, the struggle for women's empowerment has to go forward. The communists will hold their hands together with women and all other democratic forces in their struggle for justice and emancipation.

Implement Immediately Women's Reservation: NFIW

The following is the press release issued by National Federation of Indian Women (NFIW) president Aruna Roy and general secretary Annie Raja on the Women's Reservation Bill on September 21, 2023:

Founded in 1954, the National Federation of Indian Women has been spearheading the movement for political representation of women as a means of empowerment, along with strengthening and safeguarding their economic, social and human rights. Our leader and former member of Parliament Geeta Mukherjee spearheaded the campaign for political representation of women in decisionmaking bodies like Parliament and state legislative assemblies. Geeta Mukherjee, as chairperson of the Joint Select Committee on Women's Representation Bill worked hard and submitted its report well on time.

Since the first introduction of the Women's Reservation Bill in Lok Sabha in 1996 and its passage in Rajya Sabha in 2010, governments have time and again provided frivolous reasons for the delay in passing the Bill. The main reasons quoted were the need for further consideration and consensus between political parties, notwithstanding the fact that for any amendment to the Constitution, two-third majority is the criteria.

NFIW's PIL in SC on Bill: As the BJP led NDA government was not responding to the demand for the passage of the Bill, since it came to power in 2014, NFIW filed a writ petition in Supreme Court and the apex court sent notices to the Union government and all those political parties which mentioned its support in their respective election manifestoes. But the Union government did not file its response. As a result on September 5, 2023 a bench headed by Justice Sanjiv Khanna had questioned the Central government about its reluctance to file a response and as to why it is not tabling the bill in the Lok Sabha. The next hearing is on October 11, 2023.

NFIW submitted that the non-introduction of the Bill is arbitrary, illegal and is leading to discrimination. We argued that that the framers of our Constitution took note of the adverse and discriminatory position of women in our society and took consequent steps to curb the menace of discrimination and additionally to oblige the State to actively undertake welfare measures for women.

Response to Bill introduced on September 19, 2023.

• NFIW welcomes the introduction of the WR Bill in Parliament.

■ The Bill is only for 33 per cent reservation of seats for women and not 50 per cent.

■ No Fixed Time-Frame: The proposal is that the Bill, when passed, will be implemented after a census and electoral delimitation exercise in 2029. It will adversely affect the women as there will be elections to many State Assemblies before 2029. It clearly shows the reluctance and anti-women mindset of BJP government on political equality for women.

• Every time the Union government passes a Bill with the stated objective of it being beneficial to women, it means the exact opposite. It criminalized instant Triple Talaq that has shattered families with men being arrested without proof. When the sole bread winner is jailed, where does it leave the women and children?

NFIW is deeply disappointed with the fact that there is no mention of Reservation either in Rajya Sabha or in state legislative councils.

■ No mention of Trans women or OBC women in the Bill.

There is clear mention of National Capital Territory of Delhi but no mention about other Union Territories.

• No mention of Reservation for women in states which have three or less than three parliamentary constituencies.

NFIW pays its homage to Com Geeta Mukherjee and all those stalwarts, who fought for women's political empowerment.

NFIW salutes all those women and women organisations and democratic forces, who have been campaigning and struggling for passage of women's reservation.

We thank the Supreme Court for pushing the Modi government to introduce the Women's Reservation Bill in Parliament.

Going backwards

Indian Farmers, according to the Agriculture Ministry, harvested a record 112.7 million tonnes (mt) of wheat in 2022-23. Government agencies bought only 262 mt of that crop, as against the all-time-high procurement of 43.3 mt two years ago. Together with the ban on wheat exports since May 2022, these should have translated into higher open market supplies, exerting downward pressure on prices. Yet, recent government actions suggest the opposite. In June, stock limits were clamped on wheat, with wholesale traders and big chain retailers not being permitted to hold more than 3,000 tonnes. Late last week, this limit was further lowered to 2,000 tones "to ensure that no artificial scarcity of wheat is created in the country". It raises the question: If domestic market availability based on official production estimates is more than adequate, why should there be any "artificial scarcity" fears or need to prevent "hoarding and unscrupulous speculation" in the cereal?

The issue isn't simply about government output data probably not squaring with ground reality that points to upward pressure on prices.

elections has led to the government disowning even the spirit of the farm laws. Officialdom has been empowered to do whatever it takes in the name of fighting food inflation—regardless of the long-term consequences. Will these incentivise agri-businesses to invest in warehousing and processing capacities or develop export markets for grown-in-India produce? The government needs to take a call on this — and also on whether it sees agriculture as a problem or an opportunity.

Manipur needs a political intervention

In any province in any part of the world, the back-to-back killings of a serving police officer and an Army personnel would evoke feelings of outrage and anger. But if these violent acts come after four months of continuous ethnic bloodshed, where every period of relative lull has only come to be shattered by an even fiercer spurt of clashes, then it should serve as a warning bell and a sign of deep worry — one that the state government would do well to heed. Since May 3, when tensions first flared up between the dominant Meitei and the tribal Kuki groups, there have been several attempts to quell the violence, but all have failed.

The civilian administration appears to have all but melted away in the hinterland, where armed men, sometimes wearing uniforms, appear

Of greater concern is how government policy and approach towards agriculture has changed. The Narendra Modi government, only three years ago, had passed the three farm reform laws. Not only were farmers granted the freedom to sell their produce anywhere and to anyone, private agri-businesses could also now purchase directly, from them. Today, in their place, there are export bans/ curbs on wheat, non-basmati rice, sugar and onion, even as tur and urad pulses too have been brought under stock limits. If these weren't enough, a floor price of 1,200 dollars per tonne, below which exports aren't allowed, has been imposed on basmati rice that is hardly consumed by low-income households.

The farm laws may have been repealed following protests that largely resulted from poor communication. But the retrograde "supply-side" actions of the last one year or more cannot be blamed on the farm unions. Worry over food inflation becoming a potent issue in the run-up to national

to have established their writ. They belie claims by the Union and state governments that violence is ebbing in the state and the situation is becoming normal on the ground. This cannot stand. No country can afford to turn a blind eye to a systematic breakdown of law and order in a province for four months, especially if it has taken 175 lives and displaced 50,000 people.

The conundrum in Manipur — that Meitei groups don't trust Assam Rifles, Kuki groups don't trust large chunks of Manipur Police, and the working relationship between the two forces appears to be fraught can only have a political solution, not a securitised one. Such a breakthrough must be urgently sought by the government, and action taken against elements — including those close to the establishment — that continue to widen the trust deficit. Nothing less will staunch the bloodshed.

Hindutva Brand Policy Fails Voters Pay No Heed to Sanatan Dharma Squabble

Hindutva brand politics seems to be in trouble in all the five poll-bound states — Telangana, Rajasthan, Madhya Pradesh, Chhattisgarh, and Mizoram — for which election schedules are to be announced within a few weeks from now. Prime Minister Narendra Modi has come on the centre stage to campaign for BJP's Hindutva brand politics, since none of these states are now left with au unanimously agreed chief minister face to project during the campaign, which is in contrast to earlier several elections, chiefly due to severe level of infighting. It is adversely affecting even their support base.

No wonder, Congress seems to be the biggest beneficiary, not only on account of the continued infighting in the BJP and its rank and file across the state, but for other reasons too, chiefly the human predicaments brought by ever-worsening economic hardships. Though the common people, who were made to ring utensils as bells to drive away Corona, on the word of Prime Minister Narendra Modi, are not now ready to act on his bidding this time and have now become somewhat meditative on how and whom to vote.

It may be noted that all BJP leaders are dependent on Narendra Modi's strength in the five pollbound states this time, and hence in a sense, Modi is contesting on all seats on behalf of BJP candidates. The weaknesses of the state BJP leadership and the contesting candidates are obvious, and hence the party does not rely on them to win these elections which are considered semi-final for the Lok Sabha election 2024, in which Modi will be seeking his third term.

This situation explains the reason why Prime Minister Narendra Modi has shifted his campaign strategy from an anti-minority Hindutva slant, the spread of minority phobia, and jingoism to the spread of opposition phobia telling the Hindu majority that the INDIA alliance is out to destroy their "Sanatan Dharma" (The Religion Eternal). His political statements imply that Hindus are in danger of total neutralization by the INDIA political alliance's

constituents. What he does not care to tell is the reality that it is in the power of none to destroy any "eternal doctrine" that we call "Sanatan Dharma" the principle on which rests the universe (Dharma Dharyate Jagat). Either Prime Minister Narendra Modi does not know this, or he willingly wants to eradicate this principle of the Religion Eternal to his communal Hindutva brand politics. Eradication of his Hindutva brand politics is possible, and all the forms of politics in the name of religions, but not the Religion Eternal (the God or nothingness personified, whatever you may like to call it) in which everything originates, lives, and finally dissolves. Anyone who believes in this doctrine is a follower of the Religion Eternal. It has nothing to do with either Hindutva brand politics or anti-Hindutva politics.

However, it is a sociopolitical concern that a prime minister is rousing and fanning religious f u n d a m e n t a l i s m , superstition, and passion among Hindus in the name of "Sanatan Dharma" which he wrongly substitutes for communal "Hindutva".

The two-day newly reconstituted Congress Working Committee (CWC) meeting in Hyderabad, on September 16-17, has decided not to fall into the communal trap laid by the **RSS-BJP** and Prime Minister Narendra Modi, who in election-bound Madhya Pradesh picked the thread from Udhayanidhi to create "INDIA alliance phobia" by alleging opposition parties having hidden agenda to destroy "Sanatan Dharma". There are negligible takers of Prime Minister Narendra Modi's statement

in Telangana and Mizoram. The electorate is by and large with non-BJP political parties. The contest in Telangana seems to be between the BRS and Congress. Since AIMIM has not been invited to join the INDIA alliance, the party is trying to forge a third front both for the Vidhan Sabha election 2023 in the state and the Lok Sabha election in 2024. The proposal does not suit the BRS, since it would not benefit it much. AIMIM overtly plays Muslim politics as the BJP plays Hindutva politics. In a house of 119, BRS (TRS in 2018) had won 88 seats, while AIMIM was able to win only seven seats. Congress had won 19 seats. BJP could win only one seat. Anti-incumbency is likely to weigh heavy on the KCRled ruling BRS, which has signalled an improvement in the political prospect of Congress, that has announced six guarantees to the people of the state.

Mizo National Front (MNF) is ruling Mizoram that had won 27 seats in 2018 in the house of 40. MNF is part of NDA, though the party is not happy with the BJP on several issues, including violence in Manipur. BJP had won one seat in 2018. Congress had won four seats, while independents won eight. Anti-incumbency marks the ruling NDA while Congress has improved a little. The vote share of MNF was 37.7 per cent while Congress had bagged around 30 per cent votes. BJP's share was 8.09 per cent and is set to lose. The state is heading for a close contest between Congress and MNF. Modi's Hindutva campaign has become hateful there in the light of Manipur violence. Modi's Hindutva campaign is stirring the electorate most in Madhya Pradesh, compared to Rajasthan and Chhattisgarh. It may be perhaps because, the BJP is the ruling party in Madhya Pradesh, and both Rajasthan and Chhattisgarh are ruled by Congress. In all three states, BJP state units are ridden with unprecedented levels of infighting which is still continuing despite all efforts of the central leadership. Additionally, the ruling BJP in Madhya Pradesh has been facing a public sentiment of double anti-incumbency both in the state and at the Centre. Hindutva's passion is visible, but public dissatisfaction with the government is so deep that it may impact their voting against the BJP.

Both in Rajasthan and Chhattisgarh, the Hindutva wind is too weak to make any major impact on the electorate from the majority community. Congress governments in both states have cared for their citizens comparatively well through numerous public welfare schemes. There has been continued infighting within the Pradesh Congress Units in both states, but it has been somehow kept under control, and the warring groups have been brought to reconciliation.

Narendra Modi's statement that the INDIA alliance has a hidden agenda of eradicating "Sanatan Dharma", did not attract the electorate in any of the five states. The general mood in all the five states does not seem to accommodate hyper-communal Hindutva propaganda of the RSS-BJP or even of Narendra Modi. Their sufferings under BJP's rule and the exposed selfishness of warring state BJP leaders, even in BJPruled Madhya Pradesh, seem to be dominating factors in their emerging electoral sentiments.

Opposition-Ruled States Refuse to Implement NEP

The RSS-BJP Union government launched a new framework for school education, even as states such as Karnataka, Tamil Nadu, and Kerala have refused to implement the National Education Policy (NEP). Several Oppositionruled states have either adopted the policy in parts or decided to postpone the implementation. The **Opposition parties have** several reservations regarding the NEP which has many flaws and the political agenda of the RSS.

Three years since the launch of the NEP in 2020 only a specific sections of it have been accepted by most states. The pushback to the policy has come mainly from Opposition-ruled states, with Kerala, Karnataka, and Tamil Nadu either delaying implementation or refusing to adopt the policy altogether.

The NEP, which was launched in July 2020 as an update to the previous 1986 policy, is a wide-ranging framework for education from the primary level all the way to higher education as claimed by the ruling communal regime. The Union Ministery of Education has released the revised draft of the National Curriculum Framework for School Education (NCF-SE). Together, the two documents will serve as a guide for designing textbooks for classes 3 to 12 to be published by the National Council of Educational Research and Training (NCERT). These textbooks are expected to be introduced by the 2024-'25 academic session.

Chief Minister Siddaramaiah said that NEP could only be repealed after making some necessary preparations. "There was no time for preparations this year. 
Deputy Chief Minister D K Shivakumar said the Karnataka government has scrapped the NEP which has been adopted by the (previous) BJP government in the state which is mischievous and regressive.Next year, the state government is coming out with the new Karnataka Education Policy.

This decision has not gone down well with the Centre, with Union Education Minister criticising the decision and urging the state not to indulge in "politics over the NEP". The communal and fascist Union government claimed that the NEP was not established in 2023 but in 2020 . . . envisioned by the educationists of this country. This is not a political document, it's а philosophical document for Higher Education released a circular piloting a "fouryear undergraduate programme with a single-exit option after three years in Kerala universities." The committee noted that its provisions are not the same as in the NEP, "which provides for multiple entryexit options".

Tamil Nadu is another state resisting the policy. The state government in 2021 refused to accept it, with the ruling DravidaMunnetra Kazhagam (DMK) writing to the Union Minister of Education with its reservations. ADMK Rajya Sabha MP, told the BJP to "concentrate in the states where they ruled to improve the literacy rate". Through NEP the Union government wants to dominate the state, dictate a policy to states like Kerala and Tamil Nadu with higher literacy rates and development? Doesn't the

Opposition-ruled states and Union Territories, Delhi, Bihar, Rajasthan, Telangana, Andhra Pradesh and West Bengal have either adopted the policy in parts or decided to postpone the implementation process. Telangana, for instance, hasn't denounced the policy but has yet to begin implementing it. Andhra Pradesh has

made significant strides in implementing the NEP, ordering a revamp of its schools as per its guidelines. The state education minister the YSRCP from government, said the state administration plans to make the most efficient use of its teachers under NEP guidelines. The AamAadmi Party (AAP) government in Delhi, too, has adopted the policy, with the Directorate of Education expressing its intentions to restructure school



education, as per the NEP, from the next academic session.

West Bengal has asked state universities to offer four-year undergraduate programmes starting with the upcoming academic session this year, following a partial adoption of the NEP. The state, however, announced its own education policy soon afterwards, making it clear that it was not going to adopt the national policy in full. The other Oppositionrules states that have begun implementing the NEP are Rajasthan, Chhattisgarh and Himachal Pradesh.

Among the BJP-ruled states, the policy has found ready acceptance and is currently in different stages of implementation across schools and colleges. Earlier this month, Uttar Pradesh government held a meeting with officials of the higher education, secondary education, and basic education departments to take stock of the NEP's implementation. Madhya Pradesh had set up a task force to chalk out a roadmap to implement the NEP the same year it was launched. Assam, Gujarat and Haryana, too, have made progress on implementation. Haryana's Kurukshetra University became the first educational institution to implement NEP in the state. All the BJP-ruled states find enough material in the NEP for implementing the RSS agenda of communalising, commercialisation and privatisation of education in the country.

The NEP, however, is not binding on states, and they remain free to accept or reject the policy. Earlier this month, the Congress government in Karnataka became the first state to announce it would repeal the NEP from the next



Services Sector Growth Slows Down

Growth in India's dominant services sector lost some steam in August as the headline Purchasing Managers' Index (PMI) figure fell to 60.1 from a 13year-high of 62.3 in July as sales slowed down amid a record increase in new export business, said a survey by S&P Global on September 5, 2023.

"Total new business increased for the twenty-fifth month in a row during August. Advertising and robust demand for services were among the reasons listed for growth. Although softer than in July, the overall expansion in sales was one of the strongest seen in 13 years," said the credit rating agency. consumer services, transport, information, communication, finance, insurance, real estate, and business services.

It noted that despite a downturn in August, the index indicated one of the strongest increases in output seen since mid-2010 as survey respondents mentioned positive appetite, consumer market favourable conditions and successful events as the reason for this growth.

Pollyanna De Lima, economics associate director at S&P Global Market Intelligence, said that Indian services companies achieved a milestone in August, as they clocked a record surge in new export business. Asia Pacific, Europe, North America and the Middle East contributed to the upturn. supported one of the best sales performances recorded over the past 13 years, and acted as a catalyst for firms to expand their workforces as well as output. Demand strength also fostered a heightened sense of optimism regarding the outlook, boding well for economic growth prospects," she said.

Services firms got new business despite hiking their charges as the overall rate of output price inflation quickened in August. "Anecdotal evidence indicated that robust demand conditions facilitated the passing on of cost increases to clients. The overall rate of input price inflation remained above that seen for output charges, despite easing since July. Monitored companies suggested that food, input and labour costs all rose over the course of August," the survey said.

Stop Mass Displacement of Ad-hoc Teachers in DU: DUTA

The following is the letter from Dinesh Varshney Janwadi leader of Shikshak Manch along with other leaders of the teacher's organization alliance- Democratic United Teachers Association on September 18, 2023, to the Vice Chancellor ofthe University of Delhi, regarding the mass displacement of ad-hoc teachers in the Hindi Department of Satyawati College (Evening):

Reports of en-masse displacement in the Department of Hindi, Satyawati College (Evening) have shocked all teachers. While the Selection Committee was held from September 1 to 5 and 12 to 16, the results are not yet announced on the college website. The fact that results have not been displayed on the website (as is the current norm) compels us to believe in the reports that close to 70-80% of serving teachers have been displaced including teachers serving for as long as 20 years.

Any injustice of this kind, on the basis of 4–6-minute interviews, which totally disregards the contribution and continuous work of a serving teacher, is completely unacceptable.

The displacement of teachers is not only an attack on the livelihood of thousands of teachers but also shows a callous disregard of the University administration towards their contribution to these institutions with their tireless work. It also has deleterious academic consequences. The tragic incident wherein Samarveer Singh, a young talented teacher, was forced to take his life after being thrown out of his job in the Department of Philosophy, Hindu College highlights the pain of many young teachers who have unjustly lost their jobs. This unfair loss has happened at a time when these teachers were hoping for what is arguably a welldeserved permanent job after years of serving in adhoc and temporary positions.

A teacher is created in the classroom through years of experience. It is unfortunate that trained teachers are often being replaced by those who do not have a day's teaching experience! Students in several colleges have protested the displacement of their teachers. These displacements will adversely impact the teaching-learning environment in colleges. It is surely unfortunate that even students' concerns are not being taken seriously.

Also, in many places, there are very serious allegations of politically motivated nepotism and an unfair interview process that often borders on the farcical. Candidates have been humiliated during the interview process, mocked, and have been asked questions that have no relevance to their academic discipline. For example, in an interview for English, candidates were asked the meaning of a Sanskrit Department shloka! professors have been sidelined and the opinion of teachers-in-charge is ignored. The same set of experts is being sent repeatedly to various selection committees, and 'lists' of candidates to be selected circulated beforehand, raising questions about the fairness and credibility of the entire process. In drawing the lists of experts and VC nominees, professors including Heads of Department have been largely excluded.

To add to the difficulties of those displaced, ad-hoc

made against regular vacancies, ostensibly on the basis of verbal instructions from the University. This is totally unacceptable. While the attempt of the institution should be to recruit teachers on a permanent basis against vacancies, ad-hoc appointments should be allowed against leave vacancies, retirements, or vacancies that are against variable workloads. In effect, we are looking at a scenario where guest appointments against fulltime posts have become the norm. This is not acceptable as it is neither in the favour of the institution nor of teachers. While full-time teachers remain available to students and contribute to the college through their work on committees and student societies, guest faculty are paid for a fixed number of lectures and are not necessarily available to students outside the classroom because of the nature of their appointment.

The university has been conducting interviews in colleges, finally, after almost 10 years. Though vacancies have been advertised in the past, interviews were not held for one reason or another and the number of ad-hoc teachers in the university was steadily increasing. Teachers have been demanding the absorption of ad-hoc teachers through a one-time UGC Regulation and were hoping that in the current round of interviews, justice would finally be done and all those teaching against the advertised positions would be absorbed. It was hoped that those who had tirelessly served the institutions and had worked in the best interest of students against all odds would be justly made permanent.

We appeal to the Vice Chancellor for his urgent intervention in the case of SatyawatiCollege(Evening). If true, this grave matter requires a strict, urgent, time-bound, and impartial inquiry, pending which the newly appointed OSD should be sent back to his parent college.

As the academic and administrative head of the University of Delhi, it is the responsibility of the Vice Chancellor to ensure that no more displacement happens in colleges and departments and justice is done to ad-hoc and temporary teachers. Not doing so will surely lead to more unrest in the University which will disrupt the teaching-learning process.

Household Savings Fall to Nearly 50-Year Low

Net financial savings of households fell to a nearly five-decade low of 5.1 per cent of GDP in 2022-23, down from 7.2 per cent in 2021-22, Reserve Bank of India (RBI) said on September 18m 2023. The numbers suggest a severe income crunch and likely transience of the post-pandemic rise in consumption.

Worryingly, annual financial liabilities of households rose sharply by 5.8 per cent of GDP compared with 3.8 per cent in 2021-22, indicating larger-than-usual resort to loans for consumption purposes, and purchase of real estate.

Falling or stagnant household and SME incomes, at a time of raging inflation, is probably the main reason for the subdued savings and higher borrowings.

The latest RBI data on household assets and liabilities also raise worries about the immediate growth potential of the economy. The support to growth from private consumption may turn out to be weaker than anticipated, even as a private capex cycle appears to be delayed. 16.96 trillion in 2021-22. To be sure, the trend could reverse if the economy picks up pace and real incomes grow. However, both consumption and investments could be impacted if savings don't pick up meaningfully in the current year.

In a break from trend, private consumption final expenditure (PFCE) improved to six per cent y-on-y in the first quarter of 2023-24, higher than the 2.8 per cent y-o-y in the fourth quarter of 2022-23 and 2.2 per cent y-o-y in the third quarter of 2022-23, likely helped by lower inflation. Data for July and August suggest mixed trends for consumption, with passenger wholesale car sales, auto retail sales, and air traffic doing well, but wholesale two-wheeler and tractor sales, rail passenger traffic, aviation cargo and consumer goods imports not faring as well.

The rate of increase in financial liabilities last fiscal was the second highest since Independence. Only in 2006-07, the flow was sharper at 6.7 per cent.

In absolute terms, net household assets dropped sharply from Rs 22.8 trillion in 2020-21, the pandemic year which saw a huge drop in spending, to Rs 16.96 trillion in 2021-22, and further to Rs 13.76 trillion in 2022-23. Household debt, in terms of the stock of financial liabilities, consequently remained sharply elevated at 37.6 Nikhil Gupta, economist at Motilal Oswal said the combination of weak income growth and falling financial savings, led by borrowings, is unsustainable. "We believe that consumption growth is unsustainable. Whether it will be substituted by investments is not our base case, though the jury is still out," Gupta said. According to Gupta, the household debt is the second-highest annual flow post independence.

Household savings, RBI data show, came in at Rs 13.76 trillion in 2022-23 compared with Rs



US-NATO's 'Democratic' Imperialism is Libya's Nightmare

Libyans are suffering. The reason behind is the 'democratic' armed intervention by the United States and NATO to destroy Libya. Today one should stand with Libya.

NATO's military intervention in Libya in 2011, which overthrew the regime of Muammar Gaddafi, resulted in a chaotic and murderous failed state. Libyans were forced to pay a horrific price for this catastrophe.

Hillary Clinton famously quipped "we came, he died" when Muammar Gaddafi, after seven months of US and NATO bombing, was overthrown in 2011 and killed by a mob who sodomised him with a bayonet. But Gaddafi would not be the only one to die. Libya, once the most prosperous and one of the most stable countries in Africa, a country with free healthcare and education, the right for all citizens to a home, subsidised electricity, water and gasoline, along with the lowest infant mortality rate and highest life expectancy on the continent, along with one of the highest literacy rates, swiftly fragmented into warring factions. And when the torrential rains from Storm Daniel — the climate crisis being another gift to Africa from the industrialised world — overwhelmed two decrepit dams, walls of water 20 feet high raced down to flood the port of Derna and Benghazi, leaving up to 20,000 dead according to Abdulmenam Al-Gaiti, Mayor of Derna, and some 10,000 missing.

'The fragmentation of the country's disaster management and disaster response mechanisms, as well as deteriorating infrastructure, exacerbated the enormity of the challenges. The political — as it did Iraq — as a unified and stable nation. The flood victims are part of the tens of thousands of Libyan dead resulting from our 'humanitarian intervention,' which rendered disaster relief non-existent. The world must bear responsibility for Libya's prolonged suffering. Amnesty International's 2022 Libya report also makes for grim reading. 'Militias, armed groups and security forces continued to arbitrarily detain thousands of people,' it says. 'Scores of protesters, lawyers, journalists, critics and activists were rounded up and subjected to torture and other ill-treatment, enforced disappearances and forced 'confessions' on camera.' Detained migrants and refugees were subjected to torture, unlawful killings, sexual violence and forced labour.'

Stockpiles of weapons and ammunition estimated to be between 150,000 and 200,000 tons — were looted from Libya with many being trafficked to neighbouring states.

The misery and carnage, which rippled out from a dismembered Libya, was unleashed in the name of democratisation, nationbuilding, promoting the rule of law and human rights.

Military intervention is good for Iraqis, Afghans or Libyans, but not for Palestinians or Yeminis. Human rights are supposedly sacrosanct when discussing Cuba, Venezuela and Iran, but irrelevant in our offshore penal colonies, the world's largest open-air prison in Gaza or our droneinfested war zones. May it be the sense of freedom, the essence of beauty, the soul of creation, the light of life's truths, that stirs and puts us at unease, do not lull us into sleep, for too much sleep is a sign of death." These words of Premchand are still relevant guiding and inspiring in challenging times. We are collectively determined to be the claimants of this glorious heritage.

Restore OPS, Repeal NEP 2020: AIFUCTO

In a rare gesture of unity and solidarity, thousands of teachers, non-teaching staff, students, and voluntary organizations thronged into the streets of New Delhi to exhibit their deep-rooted resentment against National Education Policy 2020 and National Pension Scheme. Leaders of the organization also warned that they would wage a country-wide political struggle to dislodge the BJP government at the Centre if the government does not respond to the collective wisdom of the nation.

Communist Party of India (CPI) general secretary D Raja, All India Trade Union Congress (AITUC) general secretary Amarjeet Kaur, CPI(M) polit bureau members Nilotpal Bose and Tapan Sen expressed solidarity to the demands and urged to carry political struggles to dislodge BJP government and NEP 2020.

A 27-page chapter titled 'Quality of Accounts and Financial Reporting Practices' in the CAG's report number 21 of 2023 shines alight on accounting shenanigans that will leave any private conglomerate and its auditors aghast at the sheer audacity of the sharp practices in Union government accounts. completion of the delimitation exercise based on the first Census conducted after the passage of the Bill. It mandates women's reservation for 15 years from the commencement of the Act, with Parliament empowered to extend it further.

of National Legal Services Authority of India (NALSA) justice Sanjay KishanKaul said, observing that it was the poor and uneducated who end up behind bars for years while the rich get bail at an earlier date.said: "Our responsibility as judges is to ensure that the law is followed in letter and spirit and it does not discriminate between anyone on basis of the quality of legal representation they can afford, among other man-made qualifiers."

The Narendra Modi government introduced the 128th Constitutional Amendment Bill, 2023, to bring in 33% reservation for women in the Lok Sabha and all state Legislative Assemblies. This will include reserving one-third of the seats kept for SC/STs, and "as nearly as possible", one-third of the total seats in the general category.

Rotation of seats reserved for women will happen only after each subsequent delimitation exercise, to be determined by Parliament by law, as per the Bill. – *The Indian Express, September* 19.


