#### One Nation, One Election

# No Solution to Ailments of PRESENT ELECTORAL SYSTEM

The making of the Constitution commenced with a clear awareness of the immense diversity of our country and the need to address and accommodate the same while upholding the principles of justice and equality. The road towards democracy was embarked upon with a strong sense of representation and recognition. Universal adult franchise was one of the early expressions of this vision.

imilarly, a clear division of the Union and state governments was designed to aid the democratic expression of national and local aspirations. The democratically elected government operating within a federal setup becomes the legitimate medium to pursue the Constitutional vision. It is in this context that Dr Ambedkar identifies the centrality of free and fair elections, conducted at regular intervals both at the Union and state levels. To ensure the undertaking of this process smoothly, he firmly argued for the  $establishment\,of\,the\,Election$ Commission of India as an independent as well as permanent body. Article 324 of the Constitution precisely enshrines this value.

Unfortunately, contradictory to this Constitutional value, Prime Minister Narendra Modi is the staunchest cheer leader of One Nation, One Election. This needs to be called out for what it is a frontal assault on the inclusive essence of the Constitution.

A committee chaired by former President Ramnath Kovind, has been appointed to examine the possibility of the execution of this nefarious plan. It is evident from the composition and mandate of the committee that the recommendations have been formed already and the entire exercise led by Ramnath Kovind is only to give some legitimacy to an otherwise authoritarian whim.

Prime Minister Narendra Modi's obsession with 'oneness' is not hidden from anyone. From one nation, one tax to one nation, one electionitis anybody's guess whether this monolith drive has any end. Sometime back, the Law Commission of India invited views from stakeholders on holding simultaneous elections to state assemblies and the Lok Sabha and they are yet to submit a report. The question arises that when the Law Commission of India is already examining the subject, what is the need for a separate committee? It is, as said earlier, only to provide legitimacy to the

simultaneous elections where none exists. Similarly, the government constituted committee in probability will go on to produce a report that echoes the Prime Minister's views that havebeen aggressively expressed several times. This prompts us to delve deeper in the issue and examine what caused elections to Lok Sabha and state assemblies separately and whether it is desirable to hold them together.

In our current electoral system, democratically elected state governments have the right to continue in office till they enjoy the confidence of the assembly or till the expiry of their term, that is, five years. When our Constitution was being framed, Dr Ambedkar and other leaders preferred responsibility of the government over its stability. The proposal to have 'One Nation, One Election' attempts to homogenize the opinion of the people of different states, as expressed assemblies, with their opinion vis-à-vis the Union as expressed in the elections to the Lok Sabha.

In such a scenario, responsibility and accountability will be the victims as political parties will meet the people only once in five years. If we follow this in practice, if the Lok Sabha is dissolved post



a no-confidence motion or no coalition reaching a stable majority, all state assemblies will have to go through elections, regardless of whether a stable government was formed in the state or not. This is insulting the mandate people gave to the parties of the state and goes against the fundamentals of representative parliamentary democracy.

It is being argued that after the inauguration of our republic, elections to assemblies and Lok Sabha were being held together. Everyone knows that but the caveat here is that why the cycle of simultaneous elections broke in the first place. The government formed by the Communist Party of India in Kerala after the second general elections in 1957 was one reason that the cycle broke. The CPI ministry was one of the initial victims of the Article 356 of the Constitution and elections were held for the Kerala Assembly in 1960, separately from the General Elections. In the elections for

Kerala Assembly held in 1965, again separate from the general elections, no party could prove majority and elections were held again in 1967, along with the general elections. This process was natural given the nature of electoral democracy and how people exercised their franchise. Elections were neither imposed, nor denied to bring the state assembly in synchronization with the Lok Sabha elections.

After 1967, other forces emerged on the political horizon that challenged oneparty rule in most states. The dominant party lost power in as many as eight states. The results produced by the 1967 elections were evidence of greater penetration of democracy and political parties that channelized emerging aspirations of the people fared better than the dominant party in the Union in many states. In other words, the break from the cycle of simultaneous

## **Challenges to Constitution**

In the five-day session of the Parliament, which was unusual, the themes taken up were certainly not manageable in just five days, but they were all clinched in both the houses. The last session of the Parliament had concluded only on August 11 and coming session is also not very far, as it is in December. Obviously, the step was meant to bask in a glory yet to be earned, meant for pre-election days. Despite the growing discontent over the parliamentary processes in the massively populous democracy, leading to boycott by the opposition, the proceedings were started. But most shocking was the statement made by a central minister, when he said that the first session was to be the last in the building of British era, the old Parliament House, and the rest of the session would continue in the new building as part of the Hindu nationalist project to reject all colonial legacies. To get rid of exploitative legacy of colonialism means taking the country and its people out of poverty and backwardness, strengthening the bonds of mutual solidarity among diverse people, and preserving the constitutional mandate of secularism, democracy and federalism. Unfortunately, despite getting a big mandate in each of the two general elections in 2014 and 2019, the BJP government has simply used its power to impose the thinking and ideas of the RSS on our democratic set up. In the process, it is relentlessly dismantling the constitutional principles, bulldozing over people's aspirations and crushing their voices. Despite its claims, the BJP has been busy in its entire tenure building a dictatorial, majoritarian state that crushes the working people, religious and linguistic minorities, destroys the democratic system, and does not hesitate to violate the rule of law to achieve its ends.

The BJP's concept of good governance is concentrating all power into the hands of the Centre, modeled on the lines of Manu Smriti, and putting all the medieval regressive ideas into practice, including a second class status for the so called 'lower' castes, for minorities, for women, and generally for all those who labor to produce wealth. To meet all this, it has to demolish the Constitution based rule and replace it with autocratic regime. And this is what has been happening in the past nine years. On the very first day, the copies of our Constitution were distributed among the parliamentarians. But tragically, there were parts that were omitted. To mention a few, the first very victims were secularism and socialism from the preamble itself.

It is subversion of democracy. Parliament has been hijacked.

People's issues have no space in parliamentary debates. Laws are passed without getting into its all dimensions in detail. A process of systematic



neglect of Parliamentary Committees has been adopted avoiding their opinions. There are instances when important Bills have been passed either without debate or camouflaged as Finance Bills to get them passed!

So far as the power structure of the Centre and the states and their mutual relations are concerned, regional aspirations are always suppressed. Federal structure envisaged by the Constitution has been victim of chronic negligence.

One burning example is GST that is disempowering states. Under the Goods and Services Tax (GST) imposed on the country in 2017, states have no power in deciding what tax rates to impose on which commodities (barring alcohol and petroleum products), a right that was given to them under the Constitution of India. This snatches away the freedom of the states to pursue alternative strategies. The taxation system determined by the central government becomes the feature in which all state governments must fit in. Although there is a GST Council made up of representatives of all states, the Central government has established its own sway over it. As it is, the states' fiscal position is dire especially after the pandemic. With the imposition of GST their dependence on the Centre has become even more dire. It is a disastrous move that violates the federal structure of the Constitution. GST has been brought in at the demand of the big corporate sector of the country. It has resulted in the squeezing out of the smaller industrialists and ruin of the small trader. Currently some compensation is being paid by the Centre to state governments for the tax revenue losses. But there is not even a flickering flame there.

Another example of the blossoming autocracy is seen in repeated encroachment on the rights of states enshrined in the Constitution. The four Labour Codes and now repealed three agriculture related laws passed by the Parliament are examples of the same. The Labour Codes subsume 29 existing labour laws. Labour is on the concurrent list, meaning it can be legislated upon by both Centre and States. But the government at the Centre passed the Codes because it was in a hurry to favor the corporate sector by introducing hire and fire policies, fixed term employment, increased working hours and reduced minimum wage norms. It has also been putting pressure on the state governments to frame rules under these Codes so that they can be implemented. The farm laws too dealt with agriculture which is under the states' list. They were repealed earlier this year under immense pressure of the farmers'

## CPI Lauds Role of ISRO, Its Employees

Communist Party of India national council secretary Binoy Viswam MP said on September 20, 2023 that he salutes the scientists, the employees and workers who shed their tears, blood and sweat for the success of Chandrayaan-3. He was participating in the discussion in Rajya Sabha on 'India's glorious space journey marked by successful soft landing of Chandrayan-3'. He said that Chandrayaan-3, of course, is a great victorious moment for the country and for the whole world.

The CPI national council secretary said that before he speaks on the successful soft landing of Chandrayan-3, he would like to put on record the unfortunate incident that happened on September 19, that is, on the last day in the old building. When Dr Vikram Sarabhai reached there the next day in the morning, there was a big gathering. To that gathering, Bishop Pereira said: "He is a worldrenowned scientist and has come with a request that he needs some space from our property to have a scientific centre for launching a rocket from here for the country's future." He asked them: "What do you say?" The common people, the fishermen, after one minute silence, said in one voice: 'Amen', which means, we are for that. That was the beginning of Thumbarocket launching station.

The CPI national council secretary said that he had the honour and privilege to visit that centre many a times. He knew many of them right from S Somanath, chairman of the Indian Space Research Organisation (ISRO). Saying that taking all the names is not possible, he said he knew many of them very closely and they are his friends. They are a very good team of people, dedicated and committed for science and the country, and, their contribution is invaluable. They have made a record. That record is the record of human endeavour — collective and dedicated. But it is unfortunate that all those achievements of those people and the scientists are credited to the name of a single man.

#### Student Penalised on Ground of Religion

## No Quality Education in UP: SC

There cannot be any quality education if a student is sought to be penalised on the ground that he belongs to a particular community, the Supreme Court said September 25, 2023, as it pulled up the Uttar Pradesh government for shoddy probe in a case where a Muslim schoolboy was allegedly slapped by his classmates on the instruction of his teacher in Muzaffarnagar.

Voicing displeasure over the incident, the top court directed the UP government to appoint a senior IPS officer within a week to probe the case. "The teacher asked the students to beat the victim because of his religion. What kind of education is being imparted?" it said.

Abench of Justices Abhay S Oka and Pankaj Mithal, while directing that the IPS officer shall file a report in the apex court, asked the state government to conduct counselling of the victim and other students involved in the incident by professional counsellors.

"There cannot be any quality education if a student is sought to be penalised on the ground that he belongs to a particular community. There is a prima facie failure on the part of the State to comply with mandatory obligations of RTE Act and relevant rules," the bench said in its order.

It was hearing a plea filed

by Tushar Gandhi, the greatgrandson of Mahatma Gandhi, seeking speedy investigation in the case.

The top court, which perused the status report filed by the Muzaffarnagar Superintendent of Police, said it has "serious objections" to the manner in which the FIR was registered after a long delay. It said the father of the victim has made specific allegation that his son was beaten in school due to his religious faith.

"The complaint filed by the student's father related to cognizable offences but no FIR was immediately registered. Only a noncognizable report was filed initially and the FIR was registered after a long delay on September 6, almost two weeks after the incident. The father's allegations were not mentioned in the FIR... This is about quality education. Quality education includes sensitive education," the bench said.

It recorded in its order that if the allegation is correct, this may be the worst kind of physical punishment imparted by a teacher inasmuch as the teacher directed other students to assault the victim.

Additional Solicitor General KM Nataraj, appearing for the UP government, said the communal angle in the case was blown out of proportion. The bench refused to agree with his submission and said there is a video of the incident. "....it is a very serious issue and we will go deep into it. The manner in which this incident has happened should have shocked the conscience of the State," it said.

The court also took exception to the fact that counselling of the victim was done by the district welfare officer, and said this should have been done by a professional counsellor and that too of all the students involved in the incident.

"Counselling of the students including the victim has to be done by experts. This case should be investigated by a senior IPS officer and we would not let

#### Climate abdication

In 2019, the UK became the first major economy to pass a law that committed the country to end its carbon emissions by 2050. However, several experts reasoned that this carbon neutrality, or net zero, project was a subterfuge, a way of delaying immediate climate action, especially because the country was not on track to meet its previous less ambitious targets. In response, the then Boris Johnson government decided to advance the ban on new petrol and diesel cars to 2030 — a decade earlier than the UK's previous commitment. But now, Johnson's successor, Rishi Sunak, has gone against the recommendations of the Climate Change Committee, the statutory body responsible for monitoring progress on attaining the net zero target, by pushing back the ban on new fossil fuel-driven cars to 2035. Sunak has maintained that the measure will not stall UKs progress towards net zero.

At the last UNFCCC CoP, Sunak said that the rising energy prices because of the war in Ukraine are not a reason to go slow on climate change mitigation. He had urged countries to invest more heavily in renewable energy. The contradiction between the UK prime minister's stance at the UN meet and his domestic policies indicates a disturbing tendency: Developed country representatives often make the right noises at global summits but they fail to match their words with action at home. On paper, for instance, the US seems better positioned to meet its Paris Pact targets compared to the four years of climate denial under Donald Trump. Yet, independent assessments show nearly two years after Joe Biden signed an order to make America carbon neutral by 2050, the country's emissions trajectory remains uncertain. And now, days after it was party to a landmark G20 declaration that affirmed the bloc's commitment to renewables, the UK has watered down its climate plans.

#### The job question

India's bounce-back from the pandemic's economic fallout was fast and sharp. In 2021-22, not only had the GDP of Rs 149.25 lakh crore risen 9.1 per cent over the previous year, it had also surpassed the pre-Covid level. Employment however has been a different story. Azim Premji University's State of Working India 2023 draws together employment-related data from different government reports to show that the resilience of the job market, particularly for women and young graduates, has lagged that of the overall economy.

On the surface, one of the highlights of the employment data has been a sharp rise in both men and women working in the post-Covid phase and a simultaneous decline in the unemployment rate. The unemployment rate in 2021-22 was 6.6 per cent, over two percentage points lower than the same in 2019-20. The upward trend in women's employment has been notable. However, a fine-grained analysis by SWI 2023 report showed that there's been a structural deterioration in the nature of women's employment. The jump in women's employment has been driven by self-employment, particularly in the category of unpaid work. Self-employment is generally a fallback option, which suggests that the job market for women may have worsened.

This is corroborated by the inflation-adjusted monthly earnings of the self-employed over the last five years. For sure, the monthly earnings are higher than both 2019-20 and 2020-21. But the monthly earnings of Rs 12,089 in 2021-22 were lower by two cent than the same in 2017-18. There's economic stress underlying the increase in women's participation in the labour force. Little surprise then that political parties are rushing to tailor fiscal policies to provide monthly income support to women in different states! Youth unemployment has long been an area of concern.

For decades, India's structural transformation in the job market has lagged the growth in GDP. The term 'jobless growth' is shorthand for the lack of correlation between growth of GDP and employment. This phenomenon appears to have worsened for women in the post-Covid phase. It's something that deserves more attention as the contribution of women is critical if India wants to be a developed economy.

## CPI Demands 50 per cent Reservation for Women

Communist Party of India (CPI) leader K Subbarayan demanded in Lok Sabha fifty per cent reservation for women instead of 33 per cent. He was participating in the discussion on the Constitution (One Hundred and Twenty Eighth Amendment) Bill, 2023, namely Women's Reservation Bill on September 20, 2023.

He said that the stand of CPI is women should be given 50 per cent reservation instead of 33 per cent. Also the CPI is unable to support the Bill as nobody knows when this Act will come into force. Enumeration of census was not done in the year 2021. The government does not know when they would go for the census. Secondly the next census is slated to be enumerated in the year 2031. After the 2024 Elections, there is no assurance whether the bill will be implemented before the year 2029. If that is the case, as per this Act, we can presume that only after the year 2034 the government will be implementing the Act.

The CPI leader pointed out that the ruling BJP dispensation is not actually intending to give more powers to women. It has a mindset to keep women in slavery. The mindset prevailed in the past wanted that when the husband dies, his wife should also be put on the funeral pyre. As an indirect furtherance of this unwanted evil, the government is trying to delay the implementation of the Act indefinitely instead of implementing it in the year 2024.

He pointed out that there is one more important issue. The reservation is only for 15 years. After 15 years, nobody knows what will happen to this reservation.

These lacunae show that the BJP government is not wholeheartedly inclined to give women their rightful share in power.

Such gaps need to be filled. He also urged that the Bill should be amended in such a way making it suitable for implementation from the year 2024 itself. Further it should not have a fixed period of 15 years, which means that the government is not ready to extend women their rightful share in power.

K Subbarayan observed that the Communist Party of India has been tirelessly demanding women's reservation for years. In Lok Sabha then CPI member of Parliament Geetha Mukherjee had tried so much by uniting several MPs to make women's reservation areality. Such is the tradition of CPI and hence on behalf of CPI, he urged that the Act should be implemented in 2024, after removing the limitations.

# **Unemployment Time Bomb Hidden in So-called Indian 'Economic Miracle'**

An unemployed youth runs behind the car of the Indian Prime minister to seek a job. Too few jobs, too many workers and 'no plan B': The time bomb hidden in India's 'economic miracle'. Hope the Indian youth will defuse the ticking time bomb in 2024 and also defuse the myth and false promise last time that the ruling regime will provide two crore jobs every year to the youth. A new survey come out with a fact finding report that a large 42 per cent of Indian youth remain unemployed. Apart from this, the report—published by Azim Premji University — even mentions that the connection between growth and good jobs remains weak. Youth unemployment in the country is climbing sharply, a development that risks undermining the new darling of the world economy at the very moment it was expected to really take off.

This is the situation despite the claim by the BJP RSS ruled Union government that the Indian economic is growing speedily, the unemployment rate among graduates under 25 years of age touched a huge 42 percent post-Covid, compared to higher secondary (21.4 percent), secondary (18.1 percent), middle (15 percent) and others, according to a report.

Post-Covid the unemployment rate is lower than it was pre-Covid, for all education levels. But it remains above 15 per cent for graduates and more worryingly it touches a huge 42 per cent for graduates under 25 years," the report – State of Working India 2023: Social Identities a n d L a b o u r Market Outcomes.

The report mentioned that since 1990s year-on-year non-farm GDP growth and non-farm employment growth were uncorrelated with each other. However, the conception of job creation changed between

2004 and 2019 as it was interrupted by the pandemic which caused larger growth in distress employment.

The unemployment rate falls from over 40 percent for educated youth under 25 years of age to less than 5 percent for graduates who are 35 years and above, indicating that eventually graduates do find jobs. However, the key questions are, what is the nature of jobs they find and do these match their skills and aspirations?

On the issue of female employment, the report states that it rose since 2019 due to a distress-led increase

As per the caste based segregation issue, the report stated that Scheduled Caste workers declined rapidly over time in waste-related work and leather-related work, though it has not been eliminated as of 2021-22.


In the leather industry, the representation index declined sharply to 1.4 in 2021. In waste management and sewerage, over-representation of SCs decreased to 1.6 times in 2011 before increasing slightly again, as per the report.

Also, the report mentioned that lower-caste entrepreneurs are still rare.

Pradhan said that while 46 per cent (1,665) of the posts for OBCs are vacant, 37 per cent (837) and 44 per cent (505) are yet to be filled






The Union minister also said that 517 candidates were hired this year under the reserved category. Of them, 285 were OBCs, 150 SCs and 82 STs.

## DU college sacks six ad-hoc professors

A Delhi University college has sacked six senior-most ad-hoc teachers had been working at the college for the past 23 years and the juniormost for 9 years. # Near to 50 per cent reserved teaching posts vacant in central universities

Over 42 per cent of teaching posts reserved for candidates from SCs, STs and OBCs across 45 central universities are currently vacant, as per the report of the Union education ministry. Over 42 per cent of teaching posts reserved for candidates from Scheduled Castes (SCs), Scheduled Tribes (STs) and Other Backward Classes (OBCs) across 45 central universities

Responding to another question on the overall vacancies in central universities, the minister replied that as on July 1, 22,412 of the 54,512 sanctioned posts in 45 central universities, running on regular mode under the purview of the education ministry, remain unfilled.

According to the BJP RSS Union government, the vacancies arise due to retirement, resignation and additional requirements on account of enhanced students' strength. Central universities have been directed to fill up vacancies as and when arising, according to the minister.

The minister also said that through special recruitment drives, 6,087 posts have been filled up so far as per

# Radha Mohan Gokulji: Among Organizers of CPI Foundation Conference in 1925

Very few people are aware of the name of Radha Mohan Gokulji as one of the founders of CPI in its conference in Kanpur in 1925. He is an almost forgotten name now. He was among the leading organizers of this conference along with Satyabhakta, Maulana Hasrat Mohani, Arjun Lal Sethi and others, who practically constituted the organizing and reception committee of the conference.

#### **Early Life**

Radha Mohan Gokulji was born on December 15, 1865 in Gopalganj, Allahabad, under Bhadari state in Oudh (now in UP). His ancestors came from Khetri in Jaipur estate in Rajasthan. They were Agrawal Singhanias, and perhaps migrated more than 250 years ago due to loss of property and poverty. One of them worked as Poddar for Bhadari Maharaja. The place is related with Raja Rana Beni Madhav Singh, who rose in revolt in 1857 against the British rule and held the area for several days. His father was Lala Gokul Chand.

Radha Mohan got his initial education in a Buddhist Vihar nearby at the age of six. There he learnt Hindi. Following this, he was educated by Maulvi Fida Hussain. Then his father came to Shahzadpur, district Allahabad, and later shifted to Kanpur for studies, staying with his uncle. Radha Mohan was married at the age of 13. He got his further education in Agra in 1878 in St John's Collegiate. He studied English there.

Radha Mohan perhaps added his father's name and became Radha Mohan Gokulji.

In 1884 he had to leave Agra due to the collapse of his father's personal business, and he went to Allahabad seeking some job. He got the job of apprentice in accounts department at Rs 20 per month. But he clashed with a British employee, whom he beat and left the job after about nine months. Vowing never to work again under the British, he went home. He burnt all his certificates. This was in July 1886.

He also took up social reform work in Agra. He participated in a 'Shuddhi' rites of a Muslim in Arya Samaj, which was occasioned by distribution of sweets. This was resented by the orthodox people but Radha Mohan insisted on eating the sweets. He also began to propagate in favour of the widow marriage on behalf of the Arya Samaj.

In 1885 he took a share of Rs 25 in 'Swadeshi Vyapar Company' in Allahabad. Since then he always wore swadeshi cloth.

## **Under Congress Influence**

It was in 1885 that the Indian National Congress was founded in Bombay. A meeting to report about it was held in Shivrakhan Pathshala, Johnsonganj, Allahabad under the chairmanship of Pt Sunderlal and addressed by Pt Madan Mohan Malviya. About 15 persons attended, including Radha Mohan. The meeting had a deep impact on his mind.

Then he had to shift to Riwa to find a job but fell a victim to malaria and returned to Kanpur. There he started working in a journal called 'Brahmin' edited by Pt Pratap Narain.

#### In Calcutta

He reached Calcutta in the course of his work and gave tuition to some Marwari boys. He also joined the community in business and got acquainted with Jugal Kishore Birla, who was doing lot of social reform work under the Arya Samaj. Radha Mohan began to publish a journal named 'Satya Sanatan Dharma' in 1908, which did lot of reform work. It was a reformist reply to the theorthodox 'Shri Sanatan Dharma'.

#### Follower of Lajpat Rai

He studied a lot of nationalist literature and came under the influence of Lajpat Rai's views. He later wrote a biography of Lala Lajpat Rai.

In the meantime, he first lost his wife, then his daughter, and then his only son, a 16 year old boy, in 1901. He was in dire straits. He was being pressurised to remarry, but he said he would marry only a widow. Nobody agreed to that. He never married again. He first went to Gurgaon and then to Mathura during this time.

#### **Writing Extensively**


Radha Mohan wrote 'Deshka Dhan' (wealth of nation) in 1908. It was a serious critique of colonial economy and sharply criticized the colonial exploitation. He emphasized the role of labour. He wrote 'Niti Darshan' in 1912, outlining social welfare measures to improve society. Later he wrote his famous work 'Communism Kya Hai' (Whatis Communism).

After the Kakori incident, in which Ram Prasad Bismil, Ashfaqullah and others were

arrested, it was Radha Mohan who, on the basis of practical information and knowledge, reorganized the whole organization. He sent Vijay Kumar Sinha to Chandrashekhar Azad in Jhansi and called him to his residence. He was in active

of communism as well as with the details of Russian revolution and its theory and practice. This book played a big role in training up the revolutionaries of those years.

Later on, the police discovered some 150 copies



contact with such revolutionaries as Sachindranath Sanyal and others.

Radha Mohan left a deep imprint on the women's movement too. He was a great advocate of women's rights and worked tirelessly for widow remarriage and against obscurantism. His ideas, as also others, contributed to the formation of 'Bhartiya Mahila Samiti' in 1917.

Bhagat Singh also met him later on and exchanged opinions on communism. Radha Mohan had written 'What is Communism?' in Hindi in 1924, which became very popular. This was published by Satyabhakta in Brahman Press, Kanpur. It dealt extensively with principles of this book in Agra and seized them. They could be retrieved only much later.

He also arranged arms and ammunition for the revolutionaries and money too.

#### In Gandhian Movement

Radha Mohan joined the non-cooperation movement in 1921. He began to live at Satyagraha, or Asahayog, Ashram, Nagpur under the influence of Pt Sunderlal. In between he wrote a number of biographies such as of Mazzini, Garibaldi, Napoleon Bonaparte and others. The life of Napoleon was written for Nagari Pracharini Sabha.

He was also briefly associated with Hindu

Mahasabha.

#### Foundation of CPI in Kanpur,

#### 1925, and Gokulji

In 1923, Satyabhakta joined Radha Mohan Gokulji in bringing out the journal 'Pranvir' from Nagpur. Pranvir published the first quarterly report of the 'Indian Communist Party', established by Satyabhakta in Kanpur. It was signed by Satyabhakta as secretary. It said that there were 78 members of the party, mostly from Kanpur and UP. Among its prominent members, he mentioned

journals. He was widely known as a leading literary figure.

Poet Nirala considered him his first political Guru. Writing about him, Premchand said that he was a 'Modern Charvak'. According to Premchand, he was among those few who wrote fearlessly on religious, social, moral and political issues. He was against all kinds of social and religious obscurantism. He wrote a series beginning with 'Expulsion of God' in Hindi journal 'Madhuri', which ran continuously for eight years. library that Shiv Verma took Marx's Communist Manifesto and read out to Chandrashekhar Azad.

The Kanpur foundation conference of CPI elected a Central Executive Committee, of which Radha Mohan Gokulji was an elected member. The CEC held its first meeting on December 28. It decided upon the in-charges for various provinces. Radha Mohan Gokulji and Muzaffar Ahmed were made responsible for Bengal. They were made provincial secretaries to organize

morning. Shiv had seen him in 1925 at the time of the Congress session in Kanpur. Shiv was disappointed with this meeting. But his next meeting was quite warm, and Gokulji asked a number of questions, personal as well as political. He gave him 'Communism kya Hai?'

Shiv Verma had earlier read one or two books on including Marxism 'Samyavaad' by Ram Chandra Verma written in 1918. Gokulji's book was very simple and educative. Gokulji asked him a number of questions while taking back his book returned by Shiv, including 'What is communism'?.

Their mutual contacts increased, and Shiv became a firm Marxist and a Communist. Gokulji became his teacher of sorts on Marxism. It was at the house of Gokulji that Shiv first met Chandrashekhar Azad. Gokulji also helped Shiv Verma and others to buy two foreign made pistols from Rajasthan. His friend Fateh Bahadur brought the pistols hidden in a pillow. One was used by Mani Banerjee to shoot SP CID of Allahabad Banerjee, and the other was used by Bhagat Singh to kill Saunders. The same pistol was seized from Bhagat Singh at the time of assembly bomb case.

Gokulji also visited Nepal to meet Raja Mahendra Pratap but failed to meet him.

In the course of Meerut Conspiracy Case, the police raided the house of the younger brother of Gokulji in Agra. They could not find anything except copies of Communism Kya Hai?. Radha Mohan was out of the town. He was arrested in 1930 and was sent to Kanpur Jail. He was released in 1932 and made Hamirpur his area of work. He fell seriously ill in jail due to stomach problems like dysentery, etc. This

continued till his death in

He wrote extensively in journals like Pranvir, Matvala, Manorama, Maharathi, Navyug, etc.

#### **Last Days**

Radha Mohan Gokulji spent his last days in Khohi village in Hamirpur district near Kanpur. A small school was started in 1933 by Swami Brahmanand and Vrindavan Singh among small hills and greenery.

In fact, the school was a cover for several social and revolutionary activities. Youth were recruited and revolutionary underground propaganda carried on. Arms were acquired and bombs made. Police later on discovered the place.

In his '70s, Radha Mohan organized a group of youth around himself. He visited the nearby villages and gathered students to teach. Among the literature, he also taught them Pt Nehru's 'Letters from father to his daughter'. People helped by sending money by money orders. Many students and teachers stayed in the school itself and cooked and ate collectively.

Police got suspicious of Radha Mohan's activities. It was reported that a Baba in sadhu's attire was organizing the youth and training them in bomb making. The Collector called him. He went on a pony through bad roads despite not feeling well. On return he fell ill with diarrhea and dysentery.

He died after about 10 days on September 3, 1935. He was a firm atheist, but at the time of his death he uttered the words 'Hey Ram'. He was buried in the fields near Khohi. Now this site is in shambles. Dainik Vishvamitra published news of his death with a big photo of his.

Such a rare personality was associated with CPI's foundation.

## Biographies of Communist Leaders-95

#### Anil Rajimwale

Maulana Hasrat Mohani, Radha Mohan Gokulji, Rama Shankar Awasthi (editor, Vartman), Ram Gopal Vidyalankar (editor, Pranvir) and others.

It is little known that Radha Mohan was among the leading organizers of the first Communist conference, along with Satyabhakta, Maulana Hasrat Mohani and others. He was called to Kanpur by Satyabhakta in 1924 to work in the 'Indian Communist Party'. During his stay in Kanpur, Radha Mohan studied Marx, Engels, Lenin, Proudhon, Bakunin etc. He became a firm rationalist. By this time, Mohan Radha assimilated many basic concepts of communism. He had already written What is Communism, which contained explanations of Marxist concepts.

Radha Mohan had written a number of books particularly in literature as also on Marxism. He wrote and edited a number of

According to Dr Ram Vilas Sharma, Radha Mohan raised the demand for the agricultural labourer becoming owner of the land he tilled. He was also intensely against imperialism and communalism. Vijay Kumar Sinha wrote that Radha Mohan's life was closely related with this phase of communist movement. He suggested that the section on Communist movement be published separately, particularly in English.

According to Devi Dutt Joshi of Agra University, Radha Mohan was among the first in India to propagate Communist ideas through the medium of Hindi language to the masses. The famous revolutionary associate of Bhagat Singh and a wellknown Communist Shiv Verma quotes Satyabhakta to the effect that Radha Mohan and Maulana Hasrat Mohani contributed most to the success of Kanpur Communist conference. It was from Radha Mohan's provincial committees in their respective provinces.

His contact with the organized Communist movement and CPI was short-lived. He had a mixture of ideas. After 1926, he along with some members of Satybhakta's Kanpur group tried to form a Hindi Samyavadi Party. This obviously did not survive. He then took up active social work.

#### Contact with **Shiv Verma**

Shiv Verma met Gokulji first in December 1926 through Vijaya Kumar the Sinha, famous revolutionary belonging to Bhagat Singh group. Gokulji was staying those days in Karachi Khana in Kanpur among a workers' chawltype place, with two rooms. Workers used to stay in the rooms in the lower floor and Gokulji himself in the upper floor.

it to be watered down. We also want to know when the charge sheet will be filed and what protection is given to the witnesses and the victim," the bench told Nataraj, and asked him to file a report.

It said the state must take responsibility for the education of the child as "it is a case of violation of the fundamental right of the child and the rules framed by UP for the right to free and compulsory education".

The bench said the IPS officer, to be appointed by the state government, should also go into the question of whether section 153A of IPC

(promoting enmity between different groups on grounds of religion, race, place of birth, residence, language) should be invoked.

Referring to the provisions of Right to Education Act and the corresponding rules, which prohibit mental and physical harassment of students and their discrimination, the bench said under the Act, the local authority is required to ensure that no child is subjected to caste, class, religious, or gender abuse or discrimination in school.

"So, there cannot be any religious abuse in a school," the Court observed and added: "The State will have to answer the important question as to what facilities it will extend to the victim of the offence under the RTE Act for his quality education as per the Act. The State cannot expect the child to continue in the same school."

It also rejected Natraj's submission that the petitioner has invoked his status of great-grandson of Mahatma Gandhi in the petition and said it can even treat the petition as a suo motu proceeding, considering the fact that it raises allegations of state inaction and violation of fundamental rights.

"In a case like this, the state should not be concerned with the locus of the petitioner, inasmuch as this is a case where not only was the criminal law process not set in motion, but there was a violation of fundamental rights and RTE Act," it said.

The top court also impleaded the secretary of **UP Education Department** as a party to the case and sought a report from him on counselling of the students and better educational facilities for the victim. The bench said after looking at all the reports on October 30, it will consider whether any further directions are required to be issued. The Muzaffarnagar Police had booked the teacher accused of making communal comments and allegedly ordering her students to slap a Muslim classmate for not doing his homework.

The school was also served a notice by the state education department in connection with the matter. The teacher was booked after a video showed her allegedly asking students to slap the Class 2 boy in Khubbapur village and also making a communal remark.

Participating in the Constitution (One Hundred and Twenty Eighth Amendment) Bill, 2023, Sandosh Kumar P said on September 21 that the CPI has always stood for the empowerment of women. Leaders like Geeta Mukherjee instrumental in bringing women's reservation. Now, the important question is whether the government is serious in implementing this Bill. It is linking both Census and delimitation with this Bill. He wanted to know the problem in implementing the reservation in the coming elections. We have 542 Lok Sabha seats and 181 can be given. The country wants to

know the problem that is preventing the government from implementing this legislation and making it practical in the coming elections. He wanted to bring to the notice of the government that there is a case pending in the Supreme Court of India which was initiated by one of the prominent women's organisations in India, namely, National Federation of Indian Women (NFIW). That case is pending and all political parties have been made a party to it. The government of India and almost all states are also part of that case. When last time the Supreme Court asked for the steps taken by the Union government, the counsel representing the Union Government was absolutely defenceless.

The Bill in fact is a face-saving mission. India is a country which stands at 140<sup>th</sup> rank in a world report on women's role in politics that has recently come out. We wholeheartedly support this Bill, but we sincerely doubt the intention of the government.

## Fall in Job Creation Shows Economic Distress

The era of joblessness that began with Prime Minister Narendra Modi assuming his second term in 2019, has been worsening with the substantial decreasein regular job creation. Coupled with high prices and inflation, the situation pushed people into unprecedented economic distress that led rise in selfemployment rather than the so-called economic growth that the government has been boasting about.

The most recent study by Azim Premji University titled "State of Working India 2023" says that the pace of regular wage job creation has decreased due to the growth slowdown and the pandemic. The genderbased earning disparities have stagnated since 2017 when women were earning 76 percent as wage in comparison to men workers.

The connection between growth and good jobs remains weak, the study found, suggesting that "policies promoting faster growth need not promote faster job creation." Decent employment growth was faster between 2004 and 2019, as well as the share of workers with regular wage or salaried work, grew from 18 percent to 25 percent for men and 10 to 25 percent for women. However, since 2019, both have plummeted to 20 percent for women. Post-covid, unemployment rate remains above 15 percent for graduates and more worrying it touches a huge 42 percent for graduates under 25.

After falling or being stagnant since 2004, female employment rates (Women's Participation Rate or WPR is short) have risen since 2019, but for the wrong reasons. Since 2019, the increase in rate has been

due to a rise in selfemployment which was led by economic distress, not by economic growth. Before Covid, 50 percent of women were self-employed. After Covid, this rose to 60 percent. As a result, earnings from self-employment declined in real terms over this period. Even two years after the 2020 lockdown, self-employment earnings were only 85 percent of what they were in the April-June 2019 quarter.


The study has found that SC and ST entrepreneurship are still rare. SC and ST owners of enterprises are barely represented among firms employing more than

others. As of 2021-22, around 22 percent of SC workers were regular wage as compared to 32 percent of others. However, 40 percent of SC workers were in casual employment as compared to only 13 percent for others. SC workers have been increasingly moving from agriculture into construction, which has remained the principal source of casual work.

The employment structure varies far more across gender and caste identities than it does across religion, the study says. It is

employment elasticity, which is far lower than the developing country average. The most recent period (2017-2021) is an exception to the trend. Growth significantly slowed down but employment rose sharply. The study concluded based on this government data that growth and employment have been uncorrelated. However, other sources suspect the data itself and question how can employment rise when economic growth slows down? Yes, it can



20 workers. Correspondingly, upper caste overrepresentation increases with firm size.

Before 2019, economic growth pulled people out of agriculture and the share of regular salaried workers rose. But women left the workforce and informality levels remain a concern. Although the share of non-agricultural employment rose, it was not matched by a similar increase in the share of regular wage employment or employment in the organized sector.

The caste analysis shows that SC workers are far more likely to be in casual employment compared to worth noting that Muslims are less likely to hold regular wage jobs and more likely to be in own-account or casual wage work over the entire four-decade period after controlling for education, household size, state, and other relevant factors. It may be recalled that persistent underrepresentation in regular wage work was noted in the Sachar Committee Report of 2006. It continues to be a matter of concern, the study emphasized.

In the non-farm sector in India, output consistently grew much faster than employment, which resulted in a steady fall in the scenario is disturbing for educated youth, the study has pointed out, though it is still high among all below 25 years of age. Quoting the government PLFS data for 2021-22, the study highlighted unemployment rate among illiterate at 13.5 percent, literate but below primary 10.6, Primary or middle 15, secondary 18.1, higher secondary 21.4, and graduate and above 42.3 percent. For youth between 25 and 29 years of age unemployment among higher secondary was at 10.6 and among graduates and above was 22.8 percent. Even at the ages of 30 and 34, unemployment among graduates and above was as high as 9.8 percent.

The study raises a pertinent question while pointing out that graduates eventually find jobs, but what is the nature of the jobs they find, and dothese match their skills and aspirations? More research is needed on this important topic, the study suggests.

The majority of women remain outside the workforce in India due to supply and demand side challenges, the study pointed out. Female Labour Force Participation Rates (LFPR) in almost all states of the country lie below the line of best fit, which means female LFPRs are lower than predicted for their level of per capita GDP. Even if gender norms change and are no longer a barrier for women to undertake paid work, there remains the question - are there enough jobs? The study finds several pieces of evidence negatively impacting female LFPR.

Between 2017 and 2021, there was a slowdown in overall regular wage job creation but formal jobs (with a written contract and benefits) as a share of all regular wage work rose from 25% to 35%. In 2020-21(pandemic year) regular wage employment fell by 2.2 million. But this net change hides an increase in formal employment by 3 million and a loss of about 5.2 million of semi and informal regular wage employment. While half of the lost employment is accounted for by women, only a third of the increase in formal employment accrued to women. So, in net terms, women lost out on formal employment in this period. Not only that, there was a shift towards selfemployment due to distress.

elections was entirely democratic and legitimate form of the will of the people. This break itself is evident enough that in a federal parliamentary democracy, holding simultaneous elections for the House of the People and state assemblies may have a restrictive effect on the franchise and verdict of the people, as different states may throw different results unaligned with the results for the Union.

Post the demolition of the Babri Masjid, four state governments were dismissed by the President citing failure of constitutional machinery. Though the CPI is in opposition of President's rule on a principled basis, many have demanded President's rule in Manipur looking at the complete collapse of administration in the state. The proposal being pushed has no mechanism for dealing with such a situation, except to perpetuate un-democracy in the states.

One major reason being offered for the desirability of 'One Nation, One

Elections' is financial. Heavy premium is being posed on the idea as it will save the expenditure involved in holding elections by thousands of crores of rupees. Election expenses from the State are those involved in setting up polling booths, payment of TA/DA to personnel, transport arrangements, purchase of ink, etc. It is being argued that holding simultaneous elections will significantly reduce, or may halve these expenditures. However, data sourced from the Election Commission of India tells us very clearly that electoral expenses are not simple variables and should be studied carefully before making such sweeping generalized remarks.

For example, in Andhra Pradesh, simultaneous elections took place in 2014 and the average cost per assembly constituency was Rs 1.66 crores. In another large state, Madhya Pradesh, elections to the Lok Sabha and state assembly were held separately and the combined cost was Rs 1.43 crore per constituency.

Simultaneous elections or separate, the difference is small and 'One Nation, One Elections' is no panacea for electoral expenses or malpractices, except that it curtails people's democratic franchise.

Further, 'One Nation, One Election' is also going to have fixed costs that may outweigh the financial prudence argument. To hold simultaneous elections, the procurement of EVMs on an unprecedented scale itself is a large expenditure apart from their safe storage for a five years period. It is illogical to keep the EVMs locked for five years when they can be used to conduct elections in different states and local bodies, just for the sake of saving money which is not guaranteed at all. What our country needs are comprehensive electoral reforms aimed at free and fair elections, not Narendra Modi's shallow solutions. One reason being cited is reduced expenditure on account of political parties, without considering available options like state funding of elections as recommended by the Indrajit Gupta

Committee.

institutionalized corruption in the form of electoral bonds and should frame better laws to curtail money and muscle power in elections. A few enthusiastic supporters have also expressed the far-fetched expectation that 'One Nation, One Election' will reduce the instance of hate speech, since fewer rallies mean fewer instances of hate speech. The claim is only worthy of ridicule since instead of recommending stringent punishments for those who indulge in hate speech, it aims to curtail the number of interactions people have with political leaders. The bias of media houses is damaging the free flow of information that needs tackling, not homogenizing elections.

It is disturbing to see that the Union government has completely morphed into a political party perpetually concerned about elections. The majority of 2019 is being abused to turn our democracy into an electoral autocracy. For all the claims of sweeping changes, all of Narendra Modi's grand designs have been spectacular failures and have

unleashed great misery upon the people. Demonetization destroyed our economy and the faulty GST has caused the demise of hundreds of small producing units. Prime Minister Narendra Modi and his party have ably shown their concern for elections and democratic franchise in the case of Jammu and Kashmir where people are without any democratic representation from 2019 itself.

Coming together of parties with secular, democratic and patriotic values has made the BJP restless. INDIA has got under Narendra Modi's skin. BJP can see the threat to its continuation in office from the unity of democratic people. 'One Nation, One Election' and changes in the manner Chief Election Commissioner is appointed, taken together, are not BJP's answer to any of the ailments of the present electoral system. It demands comprehensive electoral including reform proportional representation and level playing field to the political parties. One Nation, One Election is a desperate attempt of BJP to remain in power and continue with trampling democracy.



per cent of the wealth. The report further said that if India's billionaires are taxed once at two per cent on their entire wealth, it would meet the requirement of Rs 40,423 crore for the nutrition of malnourished in the country for the next three years. The hunger index of India has further gone bad and the country stands at 107 among 122 nations.

While the country suffers from multiple crises like hunger, unemployment, inflation and health calamities, India's billionaires are doing extremely well for themselves. The poor, meanwhile, are unable to afford even basic necessities to survive. The number of hungry Indians increased to 350 million in 2022 from 190 million in 2018.

The failure to tax rich people and corporations fairly exacerbates inequality as governments then resort to taxing the rest of society more. Heavy reliance on consumption taxes like VAT increases inequality and is regressive in nature because poor people pay a larger share of their incomes. According to government sources the share in GST of top 10 per cent population is merely three per cent, whereas the share in GST of bottom 50 per cent is 64.5 per cent.

The government waved off Rs 14.49 lakh crore loans of defaulters in nine years whereas farmers are suffering due to indebtedness.

The attacks on the PSUs continue while the business promotion of foreign and Indian corporates is weakening the very bases of Indian economy. The recent visits of Prime Minister to USA and other countries before G-20 have exposed enough that the agenda was promotion of corporates as against our PSUs. Much of the agenda of the armament industry of US and some others was fulfilled. His visit in France has already raised the question on Raffaele and other deals.

Sixty one years' efforts of our scientists and engineers brought the success of Chandrayaan-3 mission and the nation celebrated it in right earnest. But the truth came to fore that the engineers and other staff of Hindustan Engineers Corporation (HEC), a PSU that helped ISRO did not get wages for 18 months. It was heartening to note that it is our BSNL, another PSU which has played the vital role in the communication system of Chandrayaan-3. The government is doing everything possible to favour its corporate friends to kill BSNL business. The circular of RBI asking PSBs to reach negotiated settlement willful defaulters is nothing but nakedly helping the willful looters of public money.

Demonetisation, electoral bonds and PM Care Fund with no accountability point to corruption for amassing public money. RSS-BJP government has proved to be the most corrupt one. The report makes it clear that the BJP-RSS government's policies are nakedly promoting corporates specially the two of Prime Minister's friends. This is precisely what is called building crony capitalism.

In our country we have been protesting and resisting through united opposition by the platform of the central trade unions the regressive labour law changes and codification. The central government has made rules centrally, and also through the state governments ruled by its own party or where they are ruling in coalition. In union territories, they are imposing central rules. Many of the governments are yet to frame the rules in states. The meeting called upon unions to develop bigger resistance not to let the rules framed or where these are framed, not to be allowed to notify and implement. RSS-BJP government wants to weaken the resistance to its policies from the organised trade union movement. Hence the labour law changes and codification are the tools to weaken and cripple collective bargaining.

Having failed on all counts the ruling party depends on the politics of hatred, communal divide and on 'Hindu Rashtra' slogan. The communally charged violent groups are getting boost. There are horrifying details from Haryana that police is allowing such groups to carry forward the activities of the vigilante groups in the name of cow safety/cow protection force. It is an example of state apparatus allowing private persons to take law in their own hands.

The instances of communal violence on Ram Navami Day and the incidents in religious yatra in Nuh in Haryana are indicators enough for the future events to unfold if the government continues to shelter these groups under the garb of religious activities.

The situation in Manipur continues to be volatile. The incidents of parading naked girls and women in Manipur shamed India but it did not bring any remorse to the top leaders in BJP including the Prime Minister who kept his mouth shut till the Parliament began. The BJP ruled state is exposed by several visiting teams which found that the government not only allowed the situation to worsen but was conniving in letting the situation deteriorate. The vote politics is priority of the ruling regime in the Centre than the unity and integrity of our nation and our people's living in peace and harmony.

The regressive approach in the field of education continues with the ulterior motive to make next generations to be blinded of realities. These forces would find it easier to spread myths and communal violence on emotive issues. The syllabus

is under change. The Darwintheory and industrial revolution chapters are removed from text books. Maulana Azad goes out of syllabus. Savarkar is introduced while the assassination of Mahatma Gandhi and ban imposed on RSS are removed from the books.

The misuse of government institutions has been fast paced and the instances of the use of ED, CBI, UAPA, NIA, NSA and sedition law have become are more common to suppress the opposition voices.

The highest office in the country was also not spared Narendra Modi government, which is evident from the fact the way the inauguration of new Parliament was conducted ignoring all democratic traditions and decorum by not inviting the head of the Constitution of India, President Droupadi Murmu. The naked show of religious bias as against secular traditions and use of Sengol ignoring all facts of history, as if it is transfer of throne to a new king is selfexplanatory. All these are aimed at pushing the country to an authoritarian autocratic state. The dichotomy of the situation was that the perpetrator of alleged crimes of sexual harassment was enjoying the hospitality of the government and the young wrestlers who brought laurels to the country by winning medals international competitions were being brutally lathicharged along with their supporters. The naked use of police forces to suppress the genuine causes and the movements was once again evident, but in more blatant

The treatment meted out to those who risked their own professional carriers, courageously raising the issue of sexual harassment to them, had shaken not only them but all those who cherish democracy and stand for justice.

The democratic spaces

are shrinking further and mediabeing gagged, the voice of opposition, the movement and agitations are not finding place in the media.

India is continuously slipping in the index of freedom of press. Last year India was placed at 150 out of 180 countries. This year India slipped down to 161, whereas Pakistan is 152 and Sri Lanka is at 135, Bhutan is 90. India is listed among the 37 nations considered to be worst for journalists. Death of journalist on duty is more in India than any other nation.

The battles are further being drawn sharply between the wealth producing working masses and those who exploit the labour to the hilt to maximize their profits in various parts of the world. It is the corporate loot all around and the finance capital is looking for every opportunity to gain businesses and markets in any part of the world. RSS-BJP government in our country is not only working for the amass of money by corporates specially the close friends of PM, it is also working for the foreign corporates to put their foothold more deep into our economy posing a threat to our sovereign rights on our natural resources and national

Now is the time not to leave any stone unturned to overthrow this anti-national government. AITUC has been playing significant role in the joint movement of trade unions towards this goal.

The trade unions in India evolved in democratic assertion of Indian masses against the oppression and suppression of the local exploiters and the colonial masters. Trade unions, the collective of workers to fight for their rights, for present and future is the basic tenets of a democracy. # CALL TO DEFEAT ANTI-PEOPLE, ANTI-NATIONAL BJP IN ELECTIONS

AITUC General Council met at Tiruppur in Tamil Nadu from September 22 to 24 with participation of members from 22 states and Sectoral All India Federations and Associations. The meeting discussed the prevailing political and economic situation, the status in regard to democracy, secularism and harmony in the society and the role of working class the forthcoming Parliament elections in 2024.

Thereporton political and economic development noted that the economy is in deep crises. The ever-rising prices of essential

commodities—the cereals, pulses, wheat flour, rice, cooking oil, cooking gas which had reached Rs1,200 a cylinder, 15 per cent hike inretail milk prices in last one year — are telling on the masses. It is only due to ensuing elections that Rs 200 rebate was announced on gas cylinder. It costs now more than Rs 900 per cylinder which is double than what was the price in 2014.

The rate of rise in unemployment rate is not receding, rather it is increasing. The minister for labour and employment admitted that about 1.2 crores of jobs were created in nine years against the

promise of creating two crore jobs every year. Even the claim of having created 1.2 crore jobs is an exaggeration.

The worsening of unemployment situation is a matter of serious concern. Every day the news of job cuts and lockouts are received not only from industrial hubs and service sector but also from the IT sector where highly qualified youth is in employment.


With the downfall of Adani empire after the Hindenburg report came out, the public sector

undertakings which had invested huge amount in Adani companies are in tight position. About Rs 30,000 crores of LIC and Rs 42,000 crores of SBI were invested in Adani companies. Similarly shipping company, Paradeep, GAIL, IOC, to name a few PSUs were made to invest and it is understood that the PMO played the role of a facilitator. It is worldwide known that the Prime Minister took personal interest and promoted Adani companies for their business expansion in several countries. In mines in Australia Indian government stood as guarantee for Adani

company and money arrangement was facilitated through PSU Bank, SBI. Home minister gave cover for Adani's Mauritius Company. For Port in Israel, Indian government stood for sovereign guarantee for Adani group. In Sri Lanka also reports are there that there are electricity generation contracts.

The council noted that Oxfam India's report on inequality in India released on January 16, 2023 finds that just five per cent of Indians own more than 60 per cent of the country's wealth, while the bottom 50 per cent possess only three
