# Save India, Change India

With the country inching closer to polls in five states followed by the parliamentary elections, the situation remains quite dire and critical. The sinister design of the powers to be to transform the country socially and politically in the mode of theocratic order of the Hindu Rashtra is already underway. Religious majoritarianism, curtailing press freedom, decimating the public sector to give leeway to private corporate interests, increased violence against historically marginalized communities, and heightened misogyny are just some of the phenomena in the long list of symptoms of a crumbling democracy. The prevailing reality looming large before all of us is the strangling of the ethos of justice, equality, and democracy, the cornerstone in the imagination of the new nationstate, India.

Drawing from the experiences and lessons of the anti-imperialist struggle, the nation-state was drawn up as a modern Sovereign Secular Socialist Democratic Republic. The preamble which is the keystone of the Constitution states this in the most unambiguous manner. Each of these words signify the lessons we have learnt in our great struggle against colonialism and how those lessons were to become the foundations for a plural, federal and egalitarian India. These lessons were multifaceted but intertwined in such a way that removing one could debase the foundations of the very essence of the nation that was arrived upon through long deliberations. Today, when the constitutional setup is under unprecedented strain and the idea of India threatened, it is imperative to look back at the vision and take inspiration from it to save the country from the autocratic clutches it is in and also change India.

The polity today faces a grave crisis spearheaded by the Sangh Parivar, who persists with its sectarian

tradition, remain contemptuous and dismissive of the Constitution. Absolute lack of accountability and transparency is the flavor of governance, impunity to generate and sustain violence and hate is fast becoming the normative value. The freedom movement was never a linear or homogenous one. While the uprooting of foreign rule was central, the question of imperialism as a system of oppression, landlordism and the feudal mode of production, caste hierarchy were all placed in the larger discourse by varied actors at various moments.

It is this diversity that culminated in the making of the modern republic with the firm understanding that nation building is a dynamic process that must be constructively continued while keeping with principles of equality, justice, and liberty at the Centre. The RSS and Hindu Mahasabha stand woefully in denial of this rich history. They in fact have actively sought and occupied the wrong side of D Raja

history. And it continues to do so.

It is essential that we understand what is to be protected from this all around attack. When our freedom struggle was coming to an end and the British departure was made imminent by the Quit India movement and the

Constitution makers placed great premium on equal citizenship of all based on democratic-secular principles. The proponents of divisions among people were defeated and India embarked on a journey where citizens from all backgrounds worked handin-hand towards peace and progress. Such was the commitment of our freedom



Communist Party backed RIN naval rebellion, a very narrow and specific group started demanding that India be declared a Hindu Rashtra. This demand also reached the Constituent Assembly and was met with emphatic rejection by none other than Dr Bhimrao Ambedkar who declared, "If Hindu Raj does become a fact, it will, no doubt, be the greatest calamity for this country. Hindu Raj must be prevented at any cost."

Instead of opting for a theocratic, hierarchical state,

fighters including Bhagat Singh, Ashfaqulla Khan, Makhdoom Mohiuddin, Aruna Asaf Ali, Subhas Bose, Abdul Gaffar Khan, Gandhi, towards secularism that even the horrors of partition could not shake their faith in the essential unity of Indians. This perspective of unity and harmony is being erased by giving de facto state religion status to one religion while openly discriminating others.

Ambedkar understood these measures as not only economically uplifting for a country with dire poverty, but also with far-reaching consequences for the class and caste structure of the country. He argued for a state that should actively take initiatives to demolish structural inequalities and divides. Inequality of any kind is a precursor to unrest and Ambedkar understood that if the country is to embark on a democratic journey, inequalities of class, caste, gender, and region have to be bridged. To that end, Ambedkar saw welfare state as essential and focused on details such as labour rights, nutrition, minimum wages, drinking water, and maternity benefits as constituents of a harmonious society.

These thoughts also found place in Directive Principles of State Policy but are in complete peril today. The retracting social sector of the country is producing great insecurity among people, especially the youth, and acting as a catalyst for lumpenization of society falling in the trap of rightwing extremism. The Right ideologues are already making their efforts to rewrite our history and redefine our nationhood.

The RSS emphasis on divisions is aimed to keep the society strife-ridden. Receding social sector and unqualified support to corporates are part and parcel of this agenda.

### Fascism Embarks on a Wide Offensive

'...In a more or less developed form, fascist tendencies and the germs of a fascist movement are to be found almost everywhere,' said Georgi Dimitrov, while presenting his report in the annual conference of Communist International (Comintern) in 1936, and then, cautioned, "With the development of the very deep economic crisis, fascism has embarked upon a wide offensive."

The late thirties in the last century had witnessed fascism spreading its steely hold all over. History repeats itself. Economic crisis, one of its precursors ruling over, corporate sector is the one that reaps the benefits. Financial Times, in its investigative report said that Adani group has raised the price of coal imports exorbitantly, with the aim of getting back huge profits.

It points towards the use of the "offshore intermediaries" once again which it had done earlier also in January this year. This time it is to get back five million dollar worth of coal at prices that were at times more than double than the market price. The owner of one among these firms is a Taiwanese and shareholder in Adani firms.

The report published in Financial Times is called "The mystery of the Adani Coal imports that quietly doubled in value," and discovered that Adani is not only one among the biggest coal importers, but also is instrumental in raising the fuel cost. It has been targeting keenly the numerous crowd of country's leading "millions of Indian consumers and businesses overpaying for electricity."

Gautam Adani is the owner of India's biggest private thermal power company and biggest private port operator. And hence, the FT report has described him 'Modi's Rockefeller', referring to his sharply rising fortunes in the past ten years, when his 10 listed companies had blossomed and Adani himself emerged as "India's biggest private thermal power company and biggest private port operator."

Back in January, Hindenburg Research report had brought up queries about functioning of Adani and why the questions that are quite serious are raised all over the world, not only about Adani, but globally about the regulatory mechanism in India. Stock market watchdog Securities and Exchange Board of India (SEBI)

came under fire even when the Supreme Court expert committee pointed to certain changes in rules that may have made it easier for Adani to escape scrutiny.

Denying the charges, both those levelled by Hindenburg and then of coal import over-pricing by the Financial Times, Adani has said that all of it has been vindicated by the Directorate of Revenue Intelligence (DRI's) decision this year to withdraw an appeal to the Supreme Court in a case against one of the 40 importers named in 2016. It said, "The issue of overvaluation in the import of coal was conclusively settled by India's highest court of law."

Financial Times cites the "unresolved nature of the DRI investigation and the apparent continuation of the alleged practices" raises "fresh questions about the relationship between Adani and the administration of Prime Minister Narendra Modi."



It is a fact that India has complex regulations on disclosing related-party transactions have been in place for eight years, but it is also as true as that the spirit of the law may still not be filtering into corporate behavior.

Adani Group, India's top infrastructure player, that has been embroiled in governance issues, should have been more forthcoming about doing business with a legal firm where the chairman's daughter-in-law is a partner. The Adani Group has rejected charges of wrongdoing. Adani has termed the investigation as being based on an "old, baseless allegation", and is "a clever recycling and selective misrepresentation of publicly available facts and information."

The inflation in imported coal that Financial Times alleges Adani has been doing may have sometimes, per the report, allowed it to make 52 percent profit margins in an industry where profit margins are otherwise considered low.

In all cases that Financial Times examined, Adani were properly disclosed

it says "prices in import records were far higher than those in corresponding export declarations."

During the journeys, from where they were imported back to a port in India, usually owned by Adani, "the value of the combined shipments unaccountably increased by over 70 million dollars."

Among the specific instances the Financial Times London-based financial daily has found, it says that in January 2019, coal meant for Adani, departed "the Indonesian port of Kaliorang in East Kalimantan carrying 74,820 tonnes of thermal coal destined for the fires of an Indian power station. During the voyage, something extraordinary occurred: the value of its cargo doubled."

While "in export records the price was 1.9mn dollar, plus 42,000 dollar for shipping and insurance. On arrival at India's largest commercial port, Mundra in Gujarat run by Adani, the declared import value was 4.3mn dollar."

This allowed for "52 percent profit margins" as a result of over-invoicing, and leading to unusual profits.

Financial Times says, "annual profits at Adani Enterprises quadrupled over the past five years, to earnings before interest, tax, depreciation and amortisation of 1.2bn dollar in the most recent financial year."

The London based daily says that Adani Enterprises, the group's oldest and most valuable company, generates the lion's share of its sales and profits from its coal trading division called Integrated Resources Management (IRM).

This division, "boasts of its expertise in logistics and commodity trading" based in four global offices and 19 Indian locations.

Meanwhile, Gautam Adani's brother steps down from three companies linked to Australia coal mine.

These resignations, which have not previously been reported, happened just days before the SC ordered a committee to probe if regulators had failed to oversee Adani Group. Meanwhile, SEBI is examining whether some transactions between the group and Vinod Adani were properly disclosed.

Zionist Israel has been continuously violating all international norms and agreements and the hospital massacre is the most inhuman and cruelest attack.

## What the Others Say ...

#### Helping the teacher

Where do they feel greater stress, at home or in school? Are they able to complete the syllabus on time? How does stress impact their teaching? These are some of the questions that the over four lakh teachers in Bihar's government schools will be asked as part of a mental health survey to be conducted by the end of the month. The State Council of Educational Research and Training has been tasked with this job in response to the growing number of complaints about rising teacher absenteeism and inability to teach the syllabus in time as well as reports of corporal punishment meted out to students.

While the challenges that teachers face, especially in government schools, are well known, any policy that seeks to relieve some of their pressure would require identifying the factors involved. The Bihar government's survey is an important step towards that. Teachers have pointed to the demands of non-teaching assignments such as election duty and the conduct of the recent caste survey in the state, as well as the management of the midday meal scheme which all too often keep teachers from doing justice to their primary duties. Addressing these concerns will ensure that teachers are equipped to perform the demanding job of nurturing young minds. It could also mark a turnaround for a state that has, in the past, benefitted from creative interventions in the field of education: For example, the 2006 Mukhyamantri Balika Cycle Yojana, one of the pet schemes of the Nitish Kumar government, under which girls from Class 9 to 12 were given free bicycles to go to school, resulted in the secondary school enrollment of girls increasing by 30 per cent within a year.

A majority of the students who enroll in government schools belong to socially and economically backward sections of society. It is important that they not only stay in school, but also receive quality education. The role of the teacher in creating the right environment cannot be overlooked. For Bihar — and, indeed, for other states — this is an end worth pursuing.

Helping teachers do their jobs better would serve the larger cause of ensuring a better education for the nation's young — a vision outlined in the National Education Policy, 2020 as well. Not just children — adults in the classroom need the right environment too.

#### Watch out for global headwinds

India's trade deficit, goods and services combined, in the first half (April-September) of the current fiscal year has almost halved to 39.9 billion dollars compared to 75.3 billion dollars in the same period in 2022-23. Even in goods trade — India almost always has a trade surplus in services trade — the deficit has fallen from 115.6 billion dollars to 140.8 billion dollars. This is clearly good news on the external balance front. A research note from Barclays has projected India's current account deficit at 1.1 per cent of GDP in 2023-24 compared to two per cent in 2022-23.

A cushion on external account, however, is only one aspect of the trade numbers. The latest reduction in trade deficit is a result of a reduction in both exports as well as imports. Merchandise exports are down 20 billion dollars and services exports are down almost nine billion dollars in the April-September period compared to last year. With the global economy "limping rather than sprinting", which is how the IMF described things in its World Economic Outlook projections released last week, the export deceleration will likely become stronger. Not only will this mean growth headwinds in the export-oriented manufacturing sector, but it could also slow down employment growth in IT services. There is already talk of a decline in the workforce of India's biggest IT companies and muted hiring by them this year. The Indian economy will have to rely on domestic drivers for growth until the global economy rediscovers its mojo. It is important, though to ensure the latest trade numbers should not be used to argue against India's efforts to promote import-substituting domestic manufacturing through policies such as the Production Linked Incentive (PLI) scheme. It is too early to start counting the benefits of these policies.

#### Rampages in West Asia: Zionist Onslaught of Palestinians

On October 7, 2023, the areas of Ashdod, Ashkelon, and Negev situated in the south of Israel were attacked by Hamas. More than thousand Israelis were killed and more than 150 people were taken as captives. The tactic adopted by Hamas was quite different from their usual suicide bombings and guerilla warfare. The attack which subverted the socalled brilliant and efficient Mossad, Shinbet, and Aman (intelligence units of Israel) and the surpassing of the internationally acclaimed iron dome by Hamas has shocked the whole world.

Corporate-funded media around the globe and in India are discussing the failure of Mossad and Israeli intelligence. However, it is imperative to understand the events and circumstances that led Hamas to launch an offense of this velocity.

The Israeli Defence Forces had tried to encroach into the Al Aqsa Mosque twice in 2021 and 2022.

The 11-day-long clash that happened in 2021 due to the encroachment attempt resulted in the death of more than a hundred Palestinians. The death toll was more than 150 in 2022. For the past 75 the Israeli years, government has been creating tensions in the Palestinian-dominated provinces of East Jerusalem, West Bank, and Gaza in order to divert the people's attention from internal instabilities and political failures. Anti-Palestinian rhetoric is the political weapon of Benjamin Netanyahu, current prime minister of Israel and leader of the Likud party. The winning strategy of this rightwing party is solely based on igniting clashes with Palestinians. Netanyahu has been facing a serious political crisis since 2019 due to strong charges of corruption and leakages. His 15-year tenure is notorious for the atrocities against Palestinians. According to BT Salem, a human rights organization in Israel, 2022 is regarded as the most painful and deadly year for Palestinians in West Bank, Gaza, and East Jerusalem. In 2022 only nearly thousands of Palestinians were killed.

To cover up his political downslide Netanyahu colluded with far-right wing of Zionist forces. In return for the support, he promised

court of Israel. In 2022 such an attempt in Sheikh Jarrah was stopped by the court. So Benjamin Netanyahu tried to bring the judiciary into the control of executive through legislation. This legislation received heated backlash from the people.

People came to the streets and huge protests were organized. For the first time in the history of Israel, military personnel took part in a people's movement. It was in this catastrophic liberation movement was secular throughout its history.

After the collapse of Ottoman Empire Palestine came under British control. The British colonial triumph card of divide and rule was applied here by them. As the result of the nexus between Britain, France and the Zionistmovementthatbegan in 1896, the migration and settlement of Jews from Europe to Palestine was encouraged in the same century. The aim of Zionist movement was to establish a country for Jews. Britain promised Theodor Herzl,

and cruelties. Through the wars that happened in 1956 and 1967, the Palestinian territories including West Bank and Jerusalem were annexed by Israel. Millions of Palestinians were forced to migrate. In 1959 Fatah the organization for the resistance of displaced Palestinians was formed. Following this, the organizations fighting for the liberation of Palestine came together under the umbrella of the Palestine Liberation Organization (PLO). Under the leadership of Yassar Arafat, the modus operandi of the armed resistance The first changed. independence movement, known as the First Intifada began in 1987 and resulted in the Oslo Accord of 1993. In the elections held subsequent to the peace treaty, Arafat became the president of Palestinian National Authority comprising the areas of West Bank and Gaza.

The Oslo Accord had promised the facilitation of the return of displaced Palestinians and formation of an independent Palestine with East Jerusalem as its capital. But the attempts for this fizzled out after the assassination of then-Israel prime minister Yitzhak Rabin in 1995. The discussion that was held between the succeeding prime minister and Labor party leader Ehud Barak and Yassar Arafat had no robust plans for implementing the Oslo Accord. Utilizing this juncture, Likud party leader Ariel Sharon entered Al Agsain 2000 which resulted in the second Intifada. The control of the second Intifada was taken by Hamasthrough its suicide bombing tactic.

It was in the 1970s that Israel began to fund Sheikh On Page 06

The intervention of USA in Iraq, Arab Spring, and the instabilities it caused in Syria, Yemen, and Libya, with the rise of ISIS, there came fissures in the friendship between Iran and Saudi Arabia, and the economic sanctions imposed on Qatar by GCC countries also affected the Palestine resistance.

All these internal dissections were exploited by Israel. For the past 15 years, Israel has been committing unendurable cruelties towards Palestinians. The "Abraham Accord" that was brokered by Donald Trump between Israel and the Arab countries of Bahrain, UAE, Sudan, and Morrocco was signed at the cost of the dreams of Palestinians.

The supply of food, water, and necessary materials to Gaza has been notched by Israel. Already more than a million people have been displaced in Gaza and hundreds are wounded. The UN officials termed it as the worst humanitarian crisis in West Asia. Thousands of Palestinians have died in the military attack by Israel. There are 60 lakh Palestinians residing in Gaza and West Bank.

However it is not at all sensible to support the atrocities committed by Hamas towards women and children. Any attack on civilians are highly condemnable.

With the entry of Hezbollah, a militant group operating in the borders of Lebanon the current clash has developed into a geopolitical war. Along with this, there are reports of Arabs residing in Israel being subjected to attack. There are nearly 20 lakh Arabs in Israel. Due to the extraordinary situation, Netanyahu has created a unity government including opposition parties. Benjamin Gantz leader of an opposition party joined the unity government. But YerLapid the prime opposition leader has refrained his party from joining the wartime government.

The reason is because of the ignited people's anger towards Netanyahu government, a great section of people believes that the warning about the attack provided by Egypt was purposefully neglected by Netanyahuforpolitical gains. Another prominent sinister name is that of US behind the ruckus. The support for Israel provided by USA in

every issue is to ensure an upper hand for US in the West Asian politics. But the influence of China and Russia in the current situation of Middle East is a hindrance for US in pushing its plans.

Historically India has sided with Palestinians in their struggles. In 1974 India became the first non-Arab country to endorse PLA. In 1980 PLA established its Embassy in New Delhi. In 1988 India was among the prominent countries that recognized Palestine. But the unilateral position of supporting Israel taken by Prime Minister Narendra Modi in the current issue is deplorable. This is a great betrayal to the Palestinians, especially when NarendraModi boasts himself to be the leader of global south.

The only solution for permanent peace and stability in West Asia is the establishment of an independent Palestine. There should be proactive attempts for peace, the deescalation of violence, and building consensus for the establishment of independent Palestine.



An extended reflection of this anomaly can also be seen when successful students from socially marginalized backgrounds are not seen as legitimate claimants of this educational empowerment because they are inherently viewed as less "meritorious" than their



Currently the Indian literacy rate is 77 per cent. It was 18.3 in 1947. India was referred as a nation of illiterates in the 90s. Though the India has produced the

nature of education itself. However, when socially and economically marginalized students enter education, their struggles do not necessarily remain about equal access to education but become about gaining equal opportunities and knowledge like their peers from socially and economically well-off backgrounds. Understanding and recognizing this latter issue, both as an educational problem and policy concern, is key to reforming the existing education system.

Thus it has become basic division between mental work and manual labour which crept into the history and educational studies, thus characterising that illiteracy of the working subalterns as failures to participate in modern economy and society. In official writings, illiteracy and ignorance was



featured as justification for poverty backwardness of Indian labour. But modern economy demanded for a trained, disciplined, and skilled labour force. This is was also under colonial economy. This demand resulted in setting up of varied types of industrial and technical schools. Thus there was necessity to educate the marginalised workers and labours. Examples include industrial and technical schools to train industrial artisans, factory schools to train factory children, night schools to train the urban classes, depressed-class schools to educate Dalits, craft and trade schools to reskill hereditary artisans, and Christian mission industrial schools to train converts from socially and economically poor backgrounds. Up until now, these schools catered largely to labouring castes who were destined to perform labour. For the educated and traditionally literate castes, literary schools and college, along with a few higher technical institutes such as engineering colleges and vocational institutes, were established.

The modern education system that emerged in the nineteenth century in industrialised colonies including India needed a curriculum to produce a professional and literate class, creating a blue-collar working class. Caste inequalities and caste prejudices marked who should do manual labour and who should not, who was a literate caste and who was

# Israel-Palestine Conflict Hits Indian Exporters, Maritime Industries

The Israel-Palestine conflict has sent ripples through the shipping and maritime industry, leading international companies to issue cautionary advisories and adapt their operations in the region. In view of the missile attacks and the incursion of opposing militias, the security of transporting goods through the port of Haifa has become uncertain. The transit of containers, especially hazardous materials, and the arrival of commercial vessels greatly emphasize the importance of security on this route and this could lead to a shift in the transportation of goods.

Maersk, a major player in the industry, reassured stakeholders by announcing that its port operations across Israel's key terminals are functioning without disruption. MSC echoed this sentiment, asserting that Israel's major terminals are operational, enabling them facilitate cargo delivery. However, the maritime industry is aware of the security situation, and companies such as MSC remain vigilant, pledging to monitor the situation closely and heed government guidance. This underscores the industry's adaptability and resilience in the face of geopolitical tensions. For a a testament to the shipping and maritime industry's ability to adapt, demonstrating that despite challenges and disruptions, trade and operations can persist, albeit with the necessary caution and vigilance.

According to Container Xchange, the ports directly

affected by the action include the ports of Ashdod, situated a mere 50 km from the Gaza border; Israeli port and shipyard Haifa, operated by India's own Adanis, Ashkelon, located just 15 km from the Gaza border and has been severely impacted, rendering it incapable of normal operations due to missile threats; Hadera, which in comparison carries on without disruption, and port of Eilat, which similarly remains operational. Beyond the ports, several global companies with a presence in Israel have been forced to adjust their operations. Chevron, the secondlargest U.S. oil and gas

This conflict underscores the enduring complexities of reshaping global trade and financial routes, highlighting the unpredictable nature of such endeavours.Geopolitical conflicts and global health crises, unfortunate as they are, often lead to unintended consequences, boosting profits in specific sectors. Wars tend to inflate returns for defence contractors, while the pandemic brought substantial gains for select pharmaceutical companies. The maritime industry is not immune to these dynamics, with shipowners reaping unexpected benefits from both types of crises.

We strongly condemn the indiscriminate bombing of Palestinians in Gaza by Israel, which we believe amounts to an attempt to genocide. We urge an immediate cessation of all hostilities to prevent further loss of innocent lives and



the destruction of homes and infrastructure."

The resolution further said: "Furthermore, we call for urgent and unimpeded delivery of humanitarian aid to the people of Gaza. The dire humanitarian situation demands immediate attention and action. All necessary measures must be taken to ensure that essential supplies, including food, water, and medical aid, reach the affected population without hindrance."

#### Rail Safety Being Repeatedly Compromised: CPI

Communist Party of India national council secretary Binoy Viswam MP wrote the following letter on October 12, 2013 to Union minister for railways Ashwini Vaishnaw on railway safety:

I write to you about the regrettable ways in which railway safety is being compromised despite repeated warnings on how this neglect can gravely impact the people of the country. When the wounds of the Balasore train crash are yet to heal, the derailment of North East Express on October 12 in Buxar district of Bihar came as another grim reminder of where the priorities of the government are going wrong. Luxury trains are being introduced in a frenzy while the infrastructure for the trains of the common people is being sorely forsaken.

Buxar tragedy has already claimed six lives and more than 100 are injured. The monetary cost of the derailment is estimated to be above Rs 50 crores. Fatalities from train related accidents are over 23,000 per year between 2010 and 2021 according to NCRB data. For 2021 alone, 88 collisions and 21 derailments were reported. Despite these alarming numbers, the government is engaged in photo-ops and PR management instead of taking concrete measures. The Rashtriya Rail Sanraksha Kosh (RRSK) which was created with the aim to clear the backlog of critical safety and related works of the ministry, including track renewals, strengthening of bridges, and signalling improvements among others remains critically unutilised. It is flagged by many including the CAG saying that RRSK's execution is lagging behind short deployment of funds which has defeated the objectives of improving railway safety. It is common knowledge that critical jobs related to railway safety are being handled by outsourced or contractual workers reflecting poorly on the seriousness of the government about the safety of citizens.

In this context, I urge you to realign the priorities of the railways towards the common people. I also request you to sanction generous compensation to the kin of the victims of the Buxar accident and to the injured. Those responsible for this tragedy should be brought to book and this should serve as a delayed reminder that these mishaps should be prevented at any cost in future.

The Covid-19 pandemic killed 6.9 million people, and for Disease X, the fatality rate can be much more. Presently, there are eight families of viruses on WHOs priority list, each one mutating in an unknown way and becoming more virulent because of climate change, which may lead to the occurrence of Disease X.

How prepared is India to deal with an outbreak of such a virus? In a counterfactual setting, we identified factors that led to a broken supply chain at the time when the second wave of Covid-19 hit India. Back then, Covid-19 was similar to Disease X, testing India's preparedness to fight the pandemic. There was a shortage of hospital beds and doctors.

Disruption in the medical supply chain impacted the availability of medicines, oxygen cylinders, vaccines, PPE suits, and medical equipment such ventilators.

In a paper titled, 'Need for Policy Reforms in the Aftermath of COVID-19: An Analysis of Indian Pharmaceutical Sector' released in August, we took a detailed look at the factors that led to disruption in the supply chain at the time of Covid-19. Besides, through factor-loading analysis, we ranked these factors — the higher the weight the more disruptive the factor impacting the vaccine supply chain. The results can serve as a policy toolkit next time there is a call for a mass vaccination drive and delivering the doses on time.

The factors were categorised into operational, financial, and logistic issues. A stratified sampling



approach was followed. The sample comprised medical doctors (300 in number) and pharmaceutical corporate executives (100 in number) selected from the National Capital Region (NCR) of Delhi.

Given India's supplychain exposure to China on active pharmaceutical ingredients (APIs), all the pharmaceutical companies selected in the survey either import APIs from China and use them to manufacture medicines and vaccines, or import medicinal equipment from China. Some firms are also dependent on imports from the US for certain critical inputs used in vaccine manufacturing. The stratified nature of the sample (random without sampling replacement) suggests that the results hold true across

were problems in scaling up production, particularly with respect to getting access to skilled labour and inputs needed for vaccine production.

Among the financial issues, although tariffs resulted in an increase in the price of medicines and vaccines, non-tariff measures (NTMs) gothigher weights, implying that they played a bigger role in supply-chain disruption. Interestingly, the US embargo on exporting Covid-19 raw materials for vaccines had a lower weight. Trade data shows that India's imports of Covid-19 raw materials from the US increased between October 2020 and March 2021. However, the higher price of Chinese APIs was negatively impacting the supply. The extent of priceled disruptions becomes clear from the fact that Chinese suppliers of APIs and para amino phenol (used manufacture paracetamol) increased prices by 20% and 27% in comparison to the pre-

In the light of these issues, the government took a right decision by launching the production-linked incentive scheme pharmaceutical products. India is dependent on APIs and is not yet as competitive as China with respect to many pharmaceutical products.

There is a need to build domestic capability and competitiveness in the API segment. Moreover, to ease supply-chain issues in the event of a pandemic, an independent task force comprising specialists such as doctors, economists, pharmaceutical corporate executives, and engineers has to be set up. This group can take inputs from the Integrated Health Information Platform, a Web-enabled information system tracking viral outbreaks.

All state governments should be made equal participants in such government initiatives, with their inputs considered for policymaking. Once in a while, this task force can engage in mock viraloutbreak scenarios to identify problems and ensure how to make the system work better.

## **Falling Household Savings Hurts** Consumption, Investments

Net financial savings of households as a percentage of the gross domestic product (GDP) slumped to the lowest in 47 years in 2022-23. According to the Reserve Bank of India's September bulletin, net financial savings were down to 5.1 per cent of GDP in in 2022-23 from 7.2 per cent in the previous fiscal year. This is a cause for serious concern as the figure was 11.5 per cent in 2020-21, indicating a severe income crunch and a likely transience of the postpandemic rise in consumption.

Disturbingly, the financial liabilities of households also sharply increased by 5.8 per cent last fiscal compared with 3.8 per cent in 2021-22, suggesting larger-than-usual recourse debt-driven consumption. In fact, the rate of increase in financial liabilities last fiscal was the second highest since Independence. It is true that owing to the development objectives, access to affordable credit for the household sector can alleviate the liquidity constraint, enabling them to smoothen their consumption. So, household borrowing plays acritical role. But it's equally true that excessive leverage beyond sustainable levels may start impacting the health of the financial system adversely causing economic disruptions.

The prospects of a boost in demand from higher consumption do not appear very bright as the reality is of falling or stagnant household incomes when

inflation is raging. At 6.83 per cent in August, inflation as measured by the consumer price index (CPI) has stayed above RBI's flexible inflation target of 2-6 per cent for two consecutive months. In its August monetary policy, RBI has projected CPI inflation at 5.4 per cent in 2023-24. The stress on incomes is relatively more in the countryside as real rural wages contracted for 12 straight months to March. Though there is a likelihood of a reversal of these trends if overall economic growth picks up and real household incomes grow, the financial year 2022-23 figures have a potential bearing on private investments over the near term at least. Nikhil Gupta, economist at Motilal Oswal, believes the combination of weak income growth and falling financial savings, led borrowings, unsustainable.

Asconsumption weakens, its impact on a private sector-led investment push is obvious. The Union finance ministry's latest monthly economic report highlights the "emergence of the green shoots of a private capex upcycle" based on highfrequency indicators such as rising capital goods imports, cement consumption, and auto sales. Proposals to set up new investment projects in the first quarter 2023-24 were 11.6 per cent higher than in the corresponding period of the previous fiscal according to CMIE's capex database. The official narrative also factors in the incentivization of higher private investments through production-linked

incentives in 14 key sectors, PM Gatishakti and the National Infrastructure Pipeline.

Yet the fact remains that the corporate sector is not driving the current growth story as it did earlier — a point underscored by Pronab Sen, chairman of the standing committee on

statistics, in an interview. That was possible because there was a lot of excess capacity in the system. This has not yet been fully used up. In manufacturing, capacity utilization rates rose to 76.3 per cent in th fourth quarter of 2022-23 from Covid-related lows of 47.3 per cent during first quarter of 2020-21. They need to go up much further to a point where private industry requires additional capacity. This can happen only if demand improves as the year-on-year growth curve for new orders is sloping downwards. Thus, a private capex upswing is only likely further down the road.

## Kisan Movement for Implementation of Guarantees

In his speech in the conference, Ravula Venkaiah

said that Prime Minister Narendra Modimust apologize to the farmers while withdrawing the three laws as none of the promises made have been fulfilled in last one year. C2+50 has not been made a legal guarantee for prices. LDF crop government in Kerala addssupport price for food crops per quintal and also Rs780 for bonus. To help the farmers in getting relief from heavy debts, they want tobring Kerala type of debt relief under legal guarantee authority by the government at the Centre.

They also want withdrawalof the Electricity Reforms Bill which is most

harmful to the farmers. The convention also demanded that minister of state for home affairs and his son who is responsible for the LakhimpurKheri incident should bepunished severely. He said that in order to achieve these, there is a need expand a strong farmersmovement across the country. #### On Record ...

The Supreme Court bench led by Chief Justice of India (CJI) DY Chandrachud granted a 'final opportunity' to Speaker of Maharashtra Legislative Assembly Rahul Narwekar to give a 'realistic time schedule' for disposal of disqualification petitions arising out of the Shiv Sena rift. A three-judge bench said the Speaker "is not doing his job" but "goes on to give interviews that we are a coequal branch of the government, the Supreme Court is supreme in its own way". It went on to note, "We are not satisfied with the time schedule indicated before this Court previously. The time schedule as proposed will not result in a foreseeable conclusion of disqualification pleas at a reasonably early date."-The Indian Express, October 18.

terrorism and criminal conspiracy by the Special Cell of the Delhi Police after the latter raided over 70 locations connected to NewsClick, including the homes of its employees and consultants.

CIVICUS is a global alliance "of over 10,000 civil society organisations and activists dedicated to strengthening citizen action and civil society throughout the world."

During the October 3 raids by the Delhi Police on NewsClick, electronic devices (including mobile phones, laptops and hard disks) of journalists were seized. The Police questioned at least 46

journalists associated with NewsClick. – newsclick.in, October 14.
